

### **Invoicing Requirements**

# **Dublin City University and Subsidiary Companies** [Hereinafter "DCU"]

DCU is fully committed to ensuring payments are made to suppliers for contracted goods and services within 30 days of receipt by DCU of a valid invoice. This applies unless alternative agreed payment terms have been put in place.

DCU is obliged to ensure that all valid invoices processed for payment comply with Revenue requirements and must include **ALL** the items listed below. Please note that DCU reserves the right to reject invoices missing any of the items listed below.

- 1. Company/Entity name
- 2. Company/Entity address
- 3. Company/Entity VAT registration number
- 4. Invoice number
- 5. Invoice date
- 6. Nine (9) digit DCU Purchase Order Number
- 7. Description of goods / services provided
- 8. Net amount excluding VAT
- **9.** VAT rate (including the zero rate)
- 10. VAT amount at each rate
- 11. Gross amount including VAT
