3.4 MSc IN THE MANAGEMENT & APPLICATIONS OF IT IN ACCOUNTING

Standing Committee referred back to the Course Team its proposal for a re-admission policy to the programme in respect of students who have successfully completed some or all of the taught component of the programme and received either of the exit awards of Graduate Certificate or Graduate Diploma, with a request to clarify its intentions for the Graduate Certificate (where the content has not been substantially changed over time) and to re-consider its rationale both for the upper limit of 2 years as well as for the restriction of the application of the proposed regulation to exceptional circumstances only.
