7. Proposal on the appeals process

The paper submitted by Dr Murray was discussed in detail. Issues raised included whether the administrative advantages of screening appeals might be outweighed by substantive considerations, the importance of having legal advice to hand at all stages of the process, the possible problems arising from requiring a second examiner's opinion in some cases, and the importance of specifying that informal representations to senior University management are never permitted.

<u>Agreed</u> that Dr Murray would prepare a revised proposal, incorporating suggestions made and agreed during the discussion.

8. Proposal from Oscail to restructure GC/GD/MSc in Management and Applications of IT in Accounting

<u>Approved</u>, subject to the examination regulations being amended to allow a maximum of four, not three, attempts. The Registrar has contacted Oscail to request that this change be made.

9. Any other business

A query was raised in relation to the approval by Academic Council on 11 April 2001 of the amendment to Marks and Standards in the matter of compensation regulations (Item 5.2). It was noted that the Registrar had conducted a briefing session for Faculty Administrators to clarify issues arising from this.
