3. Matters arising from the minutes

3.1 Follow-up actions from the last meeting were reported.

- 3.2** Noted that the proposal on procedures to be adopted when teaching family members or other people in relation to whom a conflict of interest might arise was to be discussed by Executive and would subsequently be discussed again by Academic Council. (Item 3.2)
- 3.3** Noted that the School of Physical Sciences had held one *viva voce* examination using videoconferencing, with the permission of the student, and that the feedback had been positive. Noted also that arrangements were in place in two other Schools (Dublin City University Business School and the School of Biotechnology) for using videoconferencing at forthcoming *viva voce* examinations. Agreed that feedback would be sought from these two Schools also and that a discussion on the issue would be held at the 7 October 2004 meeting of Standing Committee with a view to establishing the extent to which the practice was desirable and, if appropriate, to determining criteria and procedures for future reference. - 3.4** Noted that the Registry would, as soon as possible, analyse recent cases in which members of staff had presented for examination for research degrees, thereby necessitating the appointment of two external examiners rather than one, with a view to establishing whether or not it would be possible to consider introducing some flexibility with regard to the number of external examiners required in such situations. - 3.5** Noted that the Registry would, as soon as possible, devise a form to cater for applications for direct entry to Master's degrees by research. (Item 3.8)
- 3.6** Noted that the revised proposal on notional learning time within modules would be discussed by Standing Committee at a future date. (Item 3.10)
- 3.7** Noted that the guidelines on minute-writing would be recirculated to Programme Chairs and Faculty Administrators. (Item 4)
- 3.8** Noted that the need to inform Validation Committee where decisions were made to offer a previously full-time programme on a part-time basis, or *vice versa*, had been brought to the attention of the Task Force on Committee Structures.
- 3.9** Noted that the issue of external examiners' expenses had been discussed with the Director of Registry with a view to establishing whether or not any changes to the current procedures should be recommended, and that further discussions would take place in due course. (Item 5.2)

- 3.10** Noted that ongoing efforts would be made to ensure that, as far as possible, *curricula vitae* of nominated external examiners were sourced on line so as to minimise the use of paper. Agreed that a hard copy of each *curriculum vitae* thus sourced would be made available to the members of Standing Committee at meetings. (Item 5.2)
