1. Adoption of agenda

2. Minutes of the meeting of 2 September 2004

3. Matters arising from the minutes

- **3.1** Follow-up actions from the last meeting were reported.
- **3.2** <u>Noted</u> that the proposal on procedures to be adopted when teaching family members or other people in relation to whom a conflict of interest might arise would be

discussed by the working group set up by Executive to look at conflict of interest issues across the University generally. (Item 3.2)

- **3.3** <u>Noted</u> that feedback on the experience of using videoconferencing at *viva voce* examinations had now been received from the School of Physical Sciences and Dublin City University Business School. <u>Agreed</u> that, once feedback had been received from the School of Biotechnology and any other School that proposed to use videoconferencing in the near future, criteria and procedures for its use should be drawn up and submitted to Standing Committee. - **3.4** <u>Noted</u> that the Registry would, as soon as possible, analyse recent cases in which members of staff had presented for examination for research degrees, thereby necessitating the appointment of two external examiners rather than one, with a view to establishing whether or not it would be possible to consider introducing some flexibility with regard to the number of external examiners required in such situations. - **3.5** <u>Noted</u> that the Registry would, as soon as possible, devise a form to cater for applications for direct entry to Master's degrees by research. (Item 3.5)
- **3.6** <u>Noted</u> that the revised proposal on notional learning time within modules would be discussed by Standing Committee at a future date, and that the recent EUA review of the ECTS system had identified this issue as being of interest. (Item 3.6)

6.3 Review of pilot programme – concurrent research/qualifying modules (School of Mechanical and Manufacturing Engineering)

Standing Committee expressed its approval of the commitment to supporting students which is implicit in the programme and its appreciation of the detailed information which had been provided for the review.

<u>Agreed</u> that it would in fact be possible to conduct this review only after the students who had embarked on the pilot programme had completed their Master's research, and that accordingly the review should be deferred to that time. <u>Agreed</u> that, pending the review, further candidates for admission to the pilot programme would be considered by Standing Committee on a

case-by-case basis, as has been the practice up to now. <u>Agreed</u> that, to facilitate the assessment of such students, the School would be requested to apply more clearly defined criteria in selecting qualifying modules than exist at present. Specifically:

- All proposed modules should normally be at Level 5, unless a detailed argument for selecting a module or modules at a lower level was made; such an argument would be examined by Standing Committee as part of its examination of the case generally
- Where a module at a level lower than Level 5 was proposed, a threshold mark (which the student would have to obtain in order to be deemed to fulfil the requirements relating to the module for Master's qualifying purposes) higher than 55% would have to be specified
- The same requirements in terms of credit weightings should apply to all applicants, i.e. the proposed modules should lead to the same number of credits for all applicants, unless a detailed argument for proceeding otherwise was made; such an argument would be examined by Standing Committee as part of its examination of the case generally
- A brief rationale for the choice of each proposed module should be provided to Standing Committee in addition to the module code and title.

<u>Agreed</u> that, since the role of the Faculty Awards Board in relation to the pilot programme did not appear to be clear, students on the programme should be referred to the FAB only where an exceptional decision needed to be made and the results of the modules should be dealt with by a Progression and Awards Board.

6.4 Requests for special-case admission to postgraduate degree by research

6.5 Applications for direct entry to the PhD register (memorandum from School of Law and Government)

The issues raised in the memorandum were <u>noted</u>. It was <u>agreed</u> that the views of the Associate Deans for Research in the Faculties would be sought in relation to the following matters: the desirability of separating financial from academic issues when making decisions about direct entry to the PhD register; the fact that requiring students to register for a Master's degree before transferring to the PhD register has the effect of making the numbers of students doing PhD work appear lower than they in fact are; the fact that applications for direct entry have significantly increased; the fact that those who are permitted direct entry do not have to undergo any transfer

mechanism at a later stage, unlike students who are obliged to enter the Master's register first; the possibility that the approaches to this issue may vary according to discipline.

<u>Agreed</u> that the relevant form would, in the meantime, be revised to allow for the insertion of a line on which the candidate would be asked to indicate the title of the taught Master's degree and the awarding institution.

It was <u>noted</u> that there is an increasing tendency for those submitting forms to complete them manually although the facility exists to complete them electronically and this is what has been required in the recent past. It was <u>agreed</u> that all concerned be requested to submit electronically-completed forms only with effect from November 2004. It was also <u>agreed</u> that all concerned be requested to ensure that all necessary sections of all forms are completed fully.

8. Requests for exemption from modules

9. Admissions issues: (a) Leaving Certificate Biology/Agricultural Science and Home Economics; (b) points awarded for A- and AS-level examination grades

The proposal in relation to Home Economics was <u>approved</u>. The proposal in relation to Biology/Agricultural Science was <u>approved</u> subject to confirmation by a subject specialist that the syllabus for Biology and the syllabus for Agricultural Science are now so different from each other as to justify treating the two subjects separately for entry purposes. The decision in relation to A- and AS-level points

scores was deferred pending clarification about how the proposal, if approved, would affect an applicant who had obtained three A-levels only, under the now discontinued A- and AS-level system, and wished to apply under a revised points system. The proposal on obtaining information on forthcoming changes to Leaving Certificate syllabi was <u>approved</u>. It was <u>agreed</u> that, because of the urgency of making decisions about these issues and informing prospective guidance counsellors and other interested parties as soon as possible, the permission of the President would be sought to table the item at the 13 October 2004 meeting of Academic Council (provided clarification on the issues noted above had been obtained by then).
