

Autumn Resit Exam Results

Advice for Students

Exam results for the autumn resits will be published online on Tuesday 6th September. Results will be available from here - <https://examresults.dcu.ie/>

First year students - Please note that all results are now confirmed by the Programme Amendment Board. Student must now appeal if they wish to have a grade changed (see conditions on appeals at www.dcu.ie/students/az/appeals). Clarification on results codes and resit dates, please go to www.dcu.ie/registry/examinations/resits.shtml

Consultation Days: This takes place from Wednesday 7th and Thursday 8th September. All students can contact their lecturer to receive feedback on their assessments regardless if you passed or failed. Please request feedback so you understand where you need to improve if you failed an element of assessment.

Compensation General Rule: Compensation is not applied when a student is sitting a module for a second time. If a student is sitting a module for the first time (i.e. deferred module), fails less than 10 credits and the grade is 35-39%, they may be compensated at the August Boards. Please read the Marks & Standards document and contact your Chairperson for confirmation. Some programmes may have alternative rules. Appeals: Students may appeal a result once the August Boards have met and confirmed all results. It is important that a student seeks feedback on their exam during Consultation Days. There must be genuine reasons for an appeal. Appeals deadline is 16th September 2016. For more information, see - <https://www4.dcu.ie/students/az/appeals>

Registering for Failed/Deferred Modules: For those who failed/deferred a module at the Autumn Resits must now register to repeat those modules in 2016/2017. You

cannot progress to the next year of your programme until you have passed all 60 credits. Registration takes place online on September 22nd/23rd. As classes begin on September 19th, you will need to contact your faculty to get access to the timetable for that module.

Fees for Failed/Deferred Modules: The cost of registering for failed/deferred modules is billed at €55.00 per 1 Credit + €277 (once off amount). E.g. 5 Credits = €55.00 x 5 + €277 = €552. Students do not have to pay the Student Contribution in a Repeat Year however you will not be eligible for your SUSI grant in that year. Extenuating Circumstances: This is not available at this stage. You must appeal stating you had Extenuating Circumstances that you did not bring to the board originally.

Unhappy with Programme: Students who did not pass all 60 credits are not eligible to apply for an internal transfer at this stage. Please contact a Student Adviser to discuss future options at 01 700 7165 or student.support@dcu.ie
