SECTION A: MINUTES AND RELATED ISSUES

1. Adoption of the agenda

The agenda was adopted.

2. Minutes of the meeting of 14 January 2021

The minutes of the meeting of 14 January 2021 were <u>approved</u>. It was noted that formal minutes would be signed once on-campus activity resumes.

3. Matters arising from the minutes of 10 December 2020

- 3.1 It was <u>noted</u> that work on guidelines on recital performance and related capacity building is ongoing (item 3.1).
- 3.2 It was <u>noted</u> that follow up with respect to a PGR14 for a student in the School of Nursing, Psychotherapy and Community Health, which was approved subject to the form being completed by the supervisor, is ongoing (item 3.2) (original ref. 9.27, 31 August 2020).
- 3.3 It was <u>noted</u> that a subgroup of the GRSB has met on two occasions thus far, to scope out ongoing COVID related issues and to consider how these might be addressed going forward. The group also considered the second 'cost extension for research disrupted by COVID-19' call, due to be launched later today (item 5.2).
- 3.4 It was <u>noted</u> that follow up with respect to a PGR4 form for a student in DCU Business School, for which a decision was deferred pending further justification of the early

5. COVID-19: Continuity arrangements

The Chair advised the GRSB that DCU Library is working towards a phased opening of study spaces for those who require it. It is expected that this service will open on 8 March 2021.

The Chair informed the GRSB that the Graduate Studies Office ran a 'Coping with COVID' session in the previous week. A recording of the session is available to students on the GSO Loop page.

6. GSO Annual Report 2020

The 3rd annual GSO report was <u>noted</u> by the GRSB. The report provides an overview of student registration numbers and graduation numbers for 2019/20. The report also includes details of scholarships, funding and training events for that year.

The GRSB considered the completion rate figures provided in the report for 2007/08. It was noted that the figures were taken from the last fully completed cohort. It was noted that the part-time completion rate was low for that year, however, exploration of later years would be required to determine if this figure is typical. It was suggested that future reports could provide further detail on withdrawal numbers by year of study. It was noted that data being collected in the Student Engagement Survey (StudentSurvey.ie) may also provide further insight into students who have considered withdrawing.

7. Research student annual leave entitlement

The draft guidance text for annual leave arrangements was considered by the GRSB. A number of suggested amendments were considered. It was <u>agreed</u> that an updated document would be brought to the next meeting of the GRSB.
