The Chair opened the meeting thanking Ms. L. Buckley and colleagues in Registry for their work in organising the large numbers of PGR3 and PGR4 forms for today's meeting. She <u>noted</u> that Dr B. White has re-joined Graduate Research Studies Board (GRSB) as a co-opted member.

SECTION A: MINUTES AND RELATED ISSUES

1. Adoption of agenda

2. Minutes of the meeting of 5 March 2015

The minutes of the meeting of 5 March 2015 were approved and signed.

3. Matters arising from the minutes of 5 March 2015

- **3.1** It was <u>noted</u> that feedback on the DkIT Academic Regulations for Postgraduate Degrees by Research, offered in an advisory capacity, and relating to minor points of difference and wording, had been provided to colleagues in DkIT. It was indicated by Dr T. MacCormac that the suggested amendments would be considered at the first meeting of DkIT Graduate Research Studies Board. It was further <u>noted</u> that Dr R. O'Connor had agreed to be the DCU representative on DkIT's GRSB (Item 8).
- **3.2** It was <u>noted</u> that the proposed Joint Award Agreement with the Military University of Technology (MUT) had been finalised following clarification on the legal issue with the Chief Operating Officer. The Chair <u>noted</u> her thanks to Ms. G. Barry and colleagues in Registry for their assistance in this matter (Item 3.3).
- **3.3** It was <u>noted</u> that the PGR4 form would be amended from 2015-2016, with an insertion requesting Heads of School to provide a justification for the appointment of examiners where it is anticipated travel costs would be particularly high. It was confirmed that this matter would be dealt with by Registry in due course and was deemed completed (Item 3.2).
- **3.4** It was <u>noted</u> that resolution of Course Builder issues (university wide agreed descriptors for GTE modules) was awaiting the introduction of a new version of Course Builder in 2015 (Item 3.4).
- **3.5** It was <u>noted</u> that support from the Graduate Studies Office and the Teaching Enhancement Unit in terms of implementing GTE cross-cutting themes was a matter for ongoing discussion (Item 3.5).
- **3.6** It was <u>noted</u> that a broader initiative across the university on training in research integrity is ongoing (Item 3.6).
- **3.7** It was <u>noted</u> that information provided for a student (School of Communications) as an attachment to the PGR3 form but which should be incorporated into the form was being followed up by Registry (Item 3.7, originally raised 8 Sept 2015 meeting item 9.16).

- **3.8** It was <u>noted</u> that the PGR3 form (School of Nursing and Human Sciences) where a more detailed report was requested is ongoing (Item 3.8, item originally raised at 11 December meeting as Item 10.12).
- **3.9** It was <u>noted</u> that work is ongoing in relation to the proposal for the E-portfolio for Research Students (Item 3.10).
- **3.10** It was <u>noted</u> that the correction to an abstract attached to the PGR4 Form for a student in the School of Chemical Sciences is not yet complete (Item 3.11, Item 11.2, 21 Jan 2015).
- **3.11** It was <u>noted</u> that the Quality Assurance of GTE modules (not accredited under programmes) document had been published on the DCU website (Item 3.1).
- **3.12** It was <u>noted</u> that the 'Agreement for supervision of DCU registered research students by principal supervisors in MDI' had been <u>agreed</u> and signed.
- **3.13** It was <u>noted</u> that a PGR14 form (Ref GRSB/A2/11.2.2) for the School of Biotechnology had been approved by Chair's action on 18 March 2015.
- **3.14** It was <u>noted</u> that the suggested change to the title of NS5055 Qualitative Research Methods, to distinguish it from other modules with similar titles had been made (Item 4.1).
- **3.15** It was <u>noted</u> that for a School of Communications' PGR3 form, it had been confirmed that an oral examination had taken place (Item 8.7)
- **3.16** It was <u>noted</u> that a more detailed report had been provided with respect to a PGR3 form submitted by the School of Health and Human Performance (Item 8.8)
- **3.17** It was <u>noted</u> that a more detailed report had been provided with respect to a PGR3 form submitted by the School of Health and Human Performance (Item 8.9).
- **3.18** It was <u>noted</u> that a PGR3 form for the School of Law and Government which had not been approved has been resubmitted (Item 8.10, agenda item 9.13).
- **3.19** It was <u>noted</u> that the School of Electronic Engineering had been advised that a panel member cannot be the Chair for the *Viva Voce* (Item 9.4).
- **3.20** It was noted that discussions on the suite of Academic Writing modules (GS608, GS609 and GS610) was ongoing.

SECTION B: POLICY AND STRATEGY ISSUES

5. Incorporation and Graduate Research

Dr G. Flynn and Dr P. Flynn reported on the activity taking place in relation to Incorporation as follows:

- Fee and scholarship information has been compiled and provided to all stakeholders
- Postgraduate regulations have been aligned as closely as possible for all institutions
- The subgroup of the Student Experience Working Group has been working to ensure that the research admissions process for entry 2015 is ready
- Planning is now underway for the transfer of continuing research students from 2016.

6. Changes to Academic Regulations for Postgraduate Degrees by Research and Thesis

The Chair briefed Board members on the proposed changes to the Academic Regulations for Postgraduate Degrees by Research and Thesis. There was a brief discussion on the proposed change to paragraph 8.2.1, and the decision made at the GRSB meeting of 21 January 2015 was re-considered in the light of further feedback at School and Faculty level. It was <u>agreed</u> that it would be made clear in the regulations that the independent panel member is not permitted to be involved in the confirmation or transfer exam stage, or act as Chair of the *viva voce* examination.

All other proposed changes were <u>agreed</u>. Board members were asked to revert with any further feedback on the regulations to the Chair over the coming week in advance of submission to University Standards Committee and subsequently to Academic Council, for approval.

7. Supervisor sign off of thesis

The Chair introduced this item, indicating that the request to introduce the sign-off by the supervisor of the thesis had been raised informally by the Faculty of Science of Health. It was noted that there had been a number of occasions in the recent past when supervisors had not been happy for their students to submit their theses, however the students had submitted. Having researched practice in other institutions, it was found that there are a variety of practices, with some institutions having a sign-off requirement and a student right to appeal, and others, confirming the right of the student to submit.

Following a brief discussion it was suggested that some changes around the timeframe for the submission of the PGR4 form might be explored. The Chair suggested that should the Associate Dean for Research for the Faculty of Science and Health wish the issue to be given further consideration, she could bring a proposal in this regard to GRSB.

8. Joint Award Agreement with Maynooth University (3U)

The Chair outlined that the proposal to develop a joint research award with Maynooth University had arisen in the context of the 3U relationship and the two existing taught joint Masters' programmes. The proposal for a joint research award agreement had arisen from a specific request where joint funding has been secured. It was also anticipated that the requirement for such agreements with our strategic partner would increase and there was a need to have an agreed generic template in place, to apply on a case-by-case basis.

The Chair <u>noted</u> that the Vice President for Academic Affairs (Registrar) had agreed that the proposal met the bar of strategic significance set by the university policy, that no additional due diligence is required for MU and that the proposal could move forward to the drafting of an agreement. Given that there was pressure from the funding agency, the Chair had also already engaged with Maynooth University (MU) and an outline proposal had been discussed. Subject to the finer details being worked out, it has been agreed that two versions of a generic agreement would be put in place, one for DCU as administrative lead and another for MU as administrative lead and the student would also register in both institutions.

In the discussion which ensued the following items were raised:

- How the rotation of the administrative lead is managed is important to ensure that the process functions well
- A process around the inter-institutional sharing of data needs to be explored

• It was noted that the distribution of overhead, where relevant, although not under the remit of GRSB, should be addressed.

As there was a requirement from the funding agency to start the project, it was <u>agreed</u> that the student in question could register as a DCU student and a joint award agreement, to be further refined and considered by GRSB at its next meeting, could be applied subsequently.
