### **SECTION A: MINUTES AND RELATED ISSUES**

#### **1. Adoption of agenda**

The agenda was adopted subject to the addition of the following:

- Item 4.2.2, GTE, Advanced Academic Writing in Humanities
- Item 8.9: Notice of Intention to Submit for Examination (PGR4), School of Communications
- Item 10.2.1, Notification of Intention to carry out Research Abroad (PGR13), School of Nursing and Human Sciences
- One item under AOB.

#### **2. Minutes of the meeting of 18 May 2017**

The minutes of the meeting of 18 May 2017, were approved and signed by the Chair.

### **3. Matters arising from the minutes of 18 May 2017**

- 3.1** It was noted that the Academic Regulations for Postgraduate Degrees by Research and Thesis were approved at Academic Council on 19 June 2017 (Item 7).
- 3.2** It was noted that work is ongoing with respect to preparing guidelines for the MA through Creative or Performance Practice, and the document will be available for the consideration of GRSB in September 2017 (Item 6).
- 3.3** It was noted that the Residing Abroad Principles document would be the subject of further consultation with relevant units in the university. It was anticipated that an updated document would be drafted, considered by a sub-group of GRSB, and available for consideration by GRSB at its 4 September 2017 meeting (3.1).
- 3.4** It was noted that discussions are ongoing with respect to a Joint Supervision Agreement with the University of Southampton (Item 3.3).
- 3.5** It was noted that the policy in the Faculty of Engineering and Computing with respect to research integrity training is to recommend that existing staff take the Research Integrity module (Item 3.4).
- 3.6** It was noted that an investigation of mechanisms for the awarding of credits to students for the completion of the Research Integrity module is ongoing (Item 3.5).
- 3.7** It was noted that work is ongoing on a proposal to develop reciprocal arrangements to assist schools/faculties to address gender mix in the appointment of examination panels (Item 3.11.).
- 3.8** It was noted that more detailed descriptors (approved in principle by GRSB at its meeting of 18 May 2017) for the five new GTE modules, which will be part of the structure of the DCU Institute of Education structured pathway programme, will be submitted for the consideration of GRSB at its 4 September 2017 meeting (Item 4).
- 3.9** It was noted that work is ongoing to align the ‘Academic Roles and Responsibilities in Graduate Research’ document with the newly approved document ‘Guidance on the appointment and remit of the Independent Panel member’ (Item 5.3).
- 3.10** It was noted that a transfer application from the School of Nursing and Human Sciences, which had been deferred at the 18 May 2017 meeting, is on the agenda (Item 10.2.1) of this meeting (Item 10.1).
- 3.11** It was noted that matters relating to the notification of intention to submit form (PGR4) for a candidate in the School of Chemical Sciences have been resolved (Item 3.12).

- 3.12** It was noted that matters relating to the notification of intention to submit form (PGR4) for a candidate in the School of Physical Sciences have been resolved (Item 9.6).
- 3.13** It was noted that the amended notification of intention to submit form (PGR4), (change to the internal examiner), for a candidate in the School of Policy and Practice was approved by Chair's Action, 6 June 2017.
- 3.14** It was noted that, following an e-mail communication from the Chair, the following was deemed approved on 12 June 2017:

'In regards to an item titled "Doctorate of Education, Programme Regulations" initially presented to GRBSB as item 12.1 (of GRBSB on 2 March 2017) and as a follow up item 6 of GRBSB 20 April 2017, it was noted that clarification was to be sought whether Programme Regulations were required.

The outcome is, research degrees do not require Programme Regulations and the following decision is made: to withdraw both reference items from previous GRBSB meetings and to reverse any actions coming from the EdD Programme Regulations (presented on 2 March 2016).'

#### **4. Graduate Researcher Development**

The Chair commented briefly on the structured doctoral pathways as presented to GRBSB, noting the following:

- The module GS608BS, Strategies for Academic Writing, is listed as an option on a significant number of the structured doctoral pathways and there is concern about the module being over-subscribed. It was noted that schools should consider running their own discipline-specific version of the module.
- The module HR601, Leadership in the Research Environment, is listed on a number of structured doctoral pathways, however its funding has ended so it is unlikely to run in 2017-2018. It was noted that the Graduate Studies Office would seek clarification on whether or not it is likely to run in 2017-2018.
- The module NS5055, Qualitative Summer School appears on a number of pathways. Due to its popularity it was open only to Faculty of Science and Health students last year. Schools which have the module on their pathway need to be cognisant of the fact that it is a week-long summer school and there may not be the capacity for the co-ordinator to provide assessment for all students. It was noted too that students must sign up for the summer school in addition to normal DCU registration for GTE modules. It was agreed that some further investigation would be undertaken on how best to manage the registration issues around the summer school.

It was noted following discussion, that there should be consistency in the introductory paragraphs of the structured doctoral pathways—schools having deviated somewhat from the original template. It was agreed that further work would be completed to ensure a more consistent presentation of programmes for 2018.

It was noted that the gathering and collating of GTE module results was very problematic during the last examination diet (June 2017) and the process remains unsupported by the DCU ITS system. The Chair noted that a meeting had been set up with the Faculty Administrators in the first instance to look at trying to streamline and improve the process.

It was noted by the Chair that there was now an opportunity, with the introduction of a new student system, to provide significant input relating to research students into the specification for the new system.

#### **4.1 Structured Doctoral Pathways 2017-2018**

##### **4.1.1 DCU Business School**

It was queried whether or not the line ‘Note that any discipline-specific module is also accessible as a transferable skill’ was necessary. The GSO undertook to amend the documentation and inform the school.

#### 4.1.2.3 School of Mechanical and Manufacturing Engineering

##### Noted

It was noted that it is not yet clear if there will be a module co-ordinator available to run GS602A, Postgraduate Tutoring in Semester 1. This will prove problematic for students who are required to tutor. It was noted that the Chair and Dr S. Carroll are scheduled to meet with the Head of the Teaching Enhancement Unit to seek clarity on the matter.

It was noted that the module CS551A, Advanced Analytical Techniques, although included on the school pathway is not suitable for, or applicable to, the majority of School of Mechanical and Manufacturing Engineering research students. The module co-ordinator, Dr B. White outlined that due to its nature, (lab and instrument-based), intake numbers are very limited and it would be important for the School of Mechanical and Manufacturing Engineering to manage student expectation in this regard. She indicated however, that she would be happy to consider applications on a case-by-case basis.

With respect to CS551A, it was noted that the credits for the module should be corrected to reflect a 5-credit weighting.

It is recommended that the sentence 'Students who complete a minimum of 20 GTE credits will be recognised as having completed a structured PhD' is rephrased.

#### 4.1.3 Faculty of Humanities and Social Sciences

It was noted that the text referring to the Research Integrity Online Training Module on the Faculty of Humanities and Social Sciences' pathways will be changed to remove reference to a specific stream so students can choose between RI-SB01 Social and Behavioural Sciences or RI-AH01 Arts and Humanities.

##### 4.1.3.1 School of Applied Language and Intercultural Studies (SALIS)

##### Noted

The following items with respect to the SALIS pathway were noted:

- It is essential for SALIS students to be able to take the module GS602A, Postgraduate Tutoring in Semester 1 (see item 4.1.2.3)
- A change to the title of LC590 will be reflected in the structures.

- The module TP526 will be replaced with TP520, Contemporary Issues in Ecclesiology.

#### 4.1.4 DCU Institute of Education

Noted

It was noted that the DCU Institute of Education Structured Pathway 2017-2018 had been updated subsequent to publication in the GRSB papers and had been placed on the GRSB G Drive.

It was noted that the Institute of Education has renamed the ‘Structured Doctoral Pathway’ ‘PhD/Masters by Research Pathway’ to avoid any confusion with the Doctor of Education programme.

## **4.1.5 Faculty of Science and Health**

### **General comments**

It was noted that the School of Mathematical Sciences' documentation does not conform to the structured doctoral pathway template. It was noted that the Chair would contact the school in this regard.

It was requested that the full title of the School of Nursing and Human Sciences should be used consistently.

### **4.1.5.1 School of Biotechnology**

#### Noted

It was queried if the school plans to roll-out its own discipline-specific versions of GS608, Strategies for Academic Writing and GS609, Strategies for Getting Published.

The credits for CS551A, Advanced Analytical Techniques should be corrected from a credit weighting of 10 to 5.

### **4.1.5.2 School of Chemical Sciences**

#### Noted

The modules CS551A, Advanced Analytical Techniques and CS507A, Advanced Experimental Data Processing are missing from the structured doctoral pathway and should be included.

### **4.1.5.3 School of Health and Human Performance**

#### Noted

- It was queried if the school plans to roll-out its own discipline-specific versions of GS608, Strategies for Academic Writing and GS609, Strategies for Getting Published.
- A module code should be added for the Research Integrity module.

#### 4.1.5.4 School of Mathematical Sciences

Noted

It was noted that it would be preferable for the pathway documentation to follow the template.

#### 4.1.5.5 School of Nursing and Human Sciences

Noted

#### 4.1.5.6 School of Physical Sciences

Noted

It was noted that the pathway information indicates that those on the MSc programme can take between 20 and 30 credits of GTE modules, however this does not conform to the Academic Regulations for Postgraduate Degrees by Research and Thesis and should be amended to 20 credits.

### 4.2 Graduate Training Element (GTE) Modules

#### 4.2.1 PS525: Nanotechnology and Surface Analysis 2, School of Physical Sciences

Approved, subject to a check by the Associate Dean for Research of the final approval process within the Faculty

It was noted that the terminology in the module descriptor describing 'Repeat Examination' should be clarified.

#### 4.2.2 HSS: Advanced Academic Writing in Humanities

A decision on the approval of this module was deferred but it was agreed that it would be considered by Chair's Action following clarification of the following:

- Either the module is mapped to GS608, Strategies for Academic Writing, as a Faculty of Humanities and Social Sciences' version of the module or, if the intention is that the module is stand-alone and only open to Humanities and Social Sciences' students, that there is greater distinction made between this module descriptor (including the title) and the existing GS608 module descriptor.



## 5. Graduate Studies Training Analysis 2016-2017

Dr S. Carroll presented on the numbers of students attending Graduate Studies Office-run sessions by Faculty. He noted that attendance at the sessions was generally high across all sessions and categories. Attendance figures for the Research Integrity online training module were also provided.

In the discussion which followed the following points were noted:

### Training Analysis

- Bullet three on page 1 of the report should reflect the fact that the GSO-run courses are not offered in the evenings or weekends and thus are not accessible to part-time students. In the brief discussion on this issue and in light of the fact that 36% of research students are part-time, it was agreed that there is a need to review timing and delivery modes of the training to take account of those students and the multi-campus environment.

### Research Integrity module

- The progress of the Doctor of Education (EdD) is currently being reported in the Table as a 50% deficit, however students on the EdD programme have until the end of year 3 to complete the Research Integrity module, and therefore reporting on their completion rate of this module should be noted separately, as the numbers as presented are not representative of the situation.

## 6. Doctor of Education (Flexible mode)

It was noted that the Doctor of Education (flexible mode) programme was approved by Education Committee in late May 2017, however it had advised that GRBSB should be notified in advance, that the programme would involve students residing abroad in their home country after the taught modules are completed at DCU (month 18). It was noted that a Notice of Intention to Reside/Carry out Research Abroad (PGR13) and an agreement between DCU and each individual student would be submitted to GRBSB. This would take place in year 2 of the programme.

The proposal was agreed. A number of clarifications/suggestions for amendments to the submitted memo were made as follows:

- That it is made clear that the programme could be open to funded students
- That it is not possible to guarantee access for all countries where students reside to online resources through DCU library. It was noted that this issue will be addressed in the Residing Abroad Principles document currently being prepared.
