Introduction

The appointments will commence on 1 September 2017. While we welcome all good applicants the school has particular needs in the broad field of private law, (including the law of property, torts, contract), as well as company law (including corporate, business and competition law) and that may be a factor in short-listing and in final decision. Applicants who have familiarity with either European private law or comparative company law, including corporate regulation in the European Union and its member states are particularly welcome to apply.

Law at DCU

Skills and Experience

Applicants for the position must hold an honours degree, should be qualified to a post-graduate level and must have completed a doctoral qualification in law, or show proof of being about to complete it. The successful candidate will have experience of university teaching at lecturer level on a full-time basis and will be able to convincingly demonstrate a strong commitment to academic research. The successful candidate should be capable of working in a team and contributing to developing the teaching and research agenda within the School. Applicants with research and teaching interests in private law are particularly welcome.

Duties and Responsibilities:

The duties and responsibilities of the position include, but are not limited to the following:

- Teach onto modules at undergraduate and postgraduate level.
- Pursue an active research agenda with ongoing research publications in leading international academic journals and with high profile book publishers, both individually and, where appropriate, in collaboration with colleagues in DCU and elsewhere
- Supervise postgraduate research students.
- Participate actively in School activities and contribute to the development of the School's profile in teaching and research.
- Undertake administrative duties related to the position.
