## **Qualifications and Experience**

Applications are invited from academics with a track record of achievement within the Accounting discipline in higher education and who are committed to contributing to the leadership of the discipline in DCU Business School.

Applicants must have a honours degree (NFQ Level 8) and a PhD in Accounting or a related field. Applicants must have a proven track record of producing high quality research outputs, particularly high-quality peer-reviewed journal publications and they must provide evidence of a breadth of research experience and leadership capability. Additionally, both depth and breadth of teaching experience in higher education and a track record of excellence in teaching and of inspiring students is also required. It is desirable for applicants to hold a professional accounting qualification and relevant professional/industry experience is welcomed.

We are seeking applicants with a track record of achievement in research, with a pipeline of research projects that will lead to publications in high impact international journals. Applicants should be part of international research networks and have a range of research collaborators and it is desirable that they have experience of research supervision and applying for research funding. Applicants should have evidence of leading teaching and learning innovations/initiatives and should have experience of effective external engagement with the accounting profession and/or the business community.

Applicants must demonstrate excellent interpersonal and communication skills consistent with the highest quality of teaching, research, management and external engagement, together with evidence of successful teamwork and a collegial approach. The successful applicant will play an important role in the further enrichment of the School's national and international reputation and must display clear leadership attributes and skills and have the ability, and interest, to inspire and motivate colleagues with regard to all areas of activity of DCU Business School.
