## 1. Adoption of the agenda

#### 4. Strategic Academic Initiatives

#### 4.1 Teaching and Learning Strategy

The Chair presented summary vision statements for aspects of the Teaching and Learning Strategy. She informed members that the next steps involve elaborating and refining the draft vision statements for each area of focus and ensuring that the Faculty statements are aligned with these.

The Education Committee discussed each of the vision statements in turn and a number of suggestions on the draft text were recorded. The Chair informed members that feedback would be incorporated into the draft document and a refined version would be brought back to the next meeting of the Education Committee.

## 4.2 ECIU Strategic Oversight Committee, Terms of Reference

The Academic Secretary provided a brief overview of the draft Terms of Reference as circulated, noting the proposed membership takes into consideration the breadth of DCU's involvement in the ECIU consortium. She noted that there is a further layer of work required to identify what data the ECIU Strategic Oversight Committee would need in order for it to execute its functions.

The Education Committee <u>approved</u> the ECIU Strategic Oversight Committee Terms of Reference.

#### **SECTION C: PROGRAMME AND MODULE-SPECIFIC MATTERS**

#### 5. DCU Institute of Education

## 5.1 Revised Academic Offerings: Bachelor of Religious Education and English or History or Music – Year 2 and Year 4 exit awards

Professor A. Looney presented two proposed exit awards from the existing Bachelor of Religious Education and English, History or Music.

The Education Committee gave due consideration to the two proposed exit awards including the rationale provided for naming both religious education and education studies in the award titles. It was agreed that, in keeping with DCU award title standards, the title should be concise and reflective of the associated major award. It was furthermore noted that the transcript is the most appropriate mechanism for providing more detailed programme information. The following exit awards were approved:

- Year 2 exit award: Diploma in Religious Education and English/History/Music (Level 7, 60 ECTS)
- Year 4 exit award: Bachelor of Arts in Religious Education and English/History/Music (Level 8, 180 ECTS)

The Education Committee requested that the programme team give consideration to transfer options available to learners who exit with the Diploma.

# 5.2 Memo: Re-titling of Graduate Diploma in Inclusive Education, Learning Support and Special Education (for noting)

The re-titling of the Graduate Diploma in Inclusive Education, Learning Support and Special Education to Graduate Diploma in Inclusive and Special Education from 2023/24 was noted.

## 6. QQI analysis of degree classifications

The Chair briefed members on a recent request from the QQI for feedback on a proposed methodology for the analysis of trends in the attainment of award classifications across the sector. She noted that some suggested adjustments to the approach would be fed back to the QQI. She informed members that, notwithstanding a possible QQI analysis being undertaken, DCU would begin its own initial review of outlier programmes.

## 7. Any other business

Dr M. Ward informed colleagues that Dr Martina Crehan had recently been appointed as the new Head of the Teaching Enhancement Unit. The Chair thanked Professor Mark Brown for his role as acting Head and TEU colleagues for stepping up to ensure that TEU services continued to be offered during the interim period.
