The Chair informed members that the document outlining the procedures for conducting a viva voce online or using videoconferencing facilities has been updated to include an addendum that describes the three different formats of examination, the circumstances within which each is permitted and the approval process for each format, and sets out the additional responsibilities of the Independent Chairperson, the Candidate, the External Examiner, the Internal Examiner, the Principal Supervisor and the Head of School in respect of the three different formats.

5.2 Drupal Form – Requests to conduct viva voce fully online

Ms Lisa Buckley informed members that the Drupal Form was developed to allow the Independent Chairperson to provide the necessary information to GRSB so that it can consider requests to conduct a viva voce fully online.

The following changes will be made to the Drupal Form:

i. Include an additional option under "If the Candidate is residing abroad, please indicate the status of the remote supervision agreement (PGR13)" for instances where a PGR13 is not required.

ii. Include a section to allow the Independent Chairperson to indicate a tentative date for the viva voce so that Registry can determine if the request can be considered by GRSB or if it must be approved under Chairs Action.

## 5.3 Updated PGR6 Form

Ms Lisa Buckley informed members that Section E.1 of the PGR6 Form has been updated to allow the Independent Chairperson to indicate the format of oral examination. The Chair explained that the intention is to report this data on the format of oral examinations to GRSB on an annual basis to ensure that *Academic Regulations for Postgraduate Degrees by Research and Thesis* and the associated administrative and approval processes are effective and efficient.

Ms Buckley informed members that Section B3 of the PGR6 Form has been updated to include the following prompts to ensure the examiners provide sufficient information in the report following the viva voce:

- a) Please indicate if the candidate demonstrated that the thesis presented is their own work.
- b) Please indicate if the candidate demonstrated that they had an adequate understanding of the research topic and of the broader field of knowledge to which the research belongs.
- c) Please outline why the research, provides or fails to provide, a satisfactory basis to meet the award level that the thesis was submitted for.

<u>Decision Deferred</u> – It was <u>noted</u> that further discussion is required regarding the reason for this proposed change and the exact wording of the prompts to be included in Section B3 of the PGR6 Form.

The Chair informed members that *Procedures for conducting a viva voce online or using videoconferencing facilities*, the Drupal Form for requests to conduct a viva voce fully online and the revised PGR6 Form will apply from September 2023 onwards and that the changes will be communicated to students, supervisors and Independent Chairpersons by the Chair. It was <u>noted</u> that current practices will continue for the remainder of the 2022/23 academic year.

# 6. Report to GRSB on Trial of Alternative Process for Extension to the Maximum Registration Period

Ms Lisa Buckley informed members that Registry trialled an alternative process during the 2022/23 academic year with respect to students in examination who also reached their maximum registration period and were required to register in the next academic year to complete their corrections. Ms Buckley explained that a PGR14 Form was no longer requested in these instances as these students were identified using the PGR6 Form and the details reported to GRSB for consideration.

The following changes to the alternative process will be made for the 2023/24 academic year:

- i. The alternative process will only apply to students who have not yet been granted an extension to their maximum registration period by GRSB.
- ii. Necessary contextual information regarding individual students who require an extension to their maximum period of registration will be provided to GRSB so it can identify what students are required to submit a PGR14 Form.
- iii. Registry will provide the list of students who require an extension to their maximum period of registration to GRSB for consideration at its August meeting, which will allow a decision to be made so that students can commence the online registration process or submit a PGR14 Form for the next academic year as necessary.

#### 11. Any other business

11.1 Proposed Change to Academic Regulations for Postgraduate Degrees by Research and Thesis (2023/24)

The Chair informed members that, due to a proposed change to *Marks and Standards*, an additional change to *Academic Regulations for Postgraduate Degrees by Research and Thesis* for the 2023/24 academic year is required.

This proposed change involves replacing "leave of absence" with "suspension of one's study" in Section 5.2.5 of *Marks and Standards*. The Chair informed members that suspension of study will be included in *Academic Regulations for Postgraduate Degrees by Research and Thesis* amongst the types of changes to registration.

The following changes to *Academic Regulations for Postgraduate Degrees by Research and Thesis* were **approved**:

- i. Change title of Section 6 to "Changes to Registration".
- ii. Create four subsections in Section 6: 6.3. Deferral, 6.4. Suspension of Study, 6.5. Withdrawal and 6.6. Readmission.
- iii. Move 6.7 to 6.2 and include the underlined text: <u>Students who suspend their study may continue to receive their stipend if such is available, dependent on circumstances.</u>

The following changes to *Academic Regulations for Postgraduate Degrees by Research and Thesis* were considered by GRSB:

i. 6.3.1: Deletion of the strikethrough text and inclusion of the underlined text:

In some circumstances, for example in the case of illness, or financial or family circumstances, it is possible to apply for a formal temporary cessation of registration until the difficulties have been resolved There may be situations where a Student is required to defer their studies, such as changes in family or personal circumstances, work commitments, or short term illness. Deferrals should normally be are granted in keeping with DCU Marks and Standards.

a) Deletion of the strikethrough text:

There may be situations where a Student is required to defer their studies, such as changes in family or personal circumstances, work commitments, or short term illness. Deferrals are granted in keeping with DCU Marks and Standards.

- ii. 6.4: Inclusion of the underlined text:
  - 6.4.1. There may be situations where a Student is required to suspend their studies, including, maternity leave, paternity leave, adoption leave, carer's leave or long term health difficulties. Suspension of studies are granted in keeping with DCU Marks & Standards, and only in such exceptional circumstances. Suspension of study must be approved by the Supervisor and the relevant Head of School and will usually be for a half, or full academic year.
  - 6.4.2. Students wishing to suspend their study must notify the Registry, in advance, in writing by submitting an Application for Suspension of Study. Retrospective suspensions are not allowed, except in exceptional cases where a student was adversely affected by illness or other factors, which they were unable or, for valid reasons, unwilling to divulge, and is limited to half year.

6.4.3. During any temporary cessation of registration, the student's participation in the research programme is suspended and the student will not be entitled to supervision or to use the University facilities, including the Library.

- <u>6.4.4. Consistent with *DCU Marks and Standards*</u>, the maximum period of registration is extended.
- 6.4.5. Tuition fees are adjusted to account for the suspended period.

- b) Deletion of the strikethrough text:
  - 6.4.1. There may be situations where a Student is required to suspend their studies, including, maternity leave, paternity leave, adoption leave, carer's leave or long term health difficulties. Suspension of studies are granted in keeping with *DCU Marks & Standards*, and only in-such exceptional circumstances.

It was <u>noted</u> that the circumstances in which a deferral, suspension of study or withdrawal may be granted will be set out in a guidance document, which will be submitted to GRSB for consideration at its meeting in August, and will be aligned with those relating to undergraduate and postgraduate taught programmes.

11.2 Change to Location of GRSB Meeting

It was <u>noted</u> that the meeting of GRSB on 1 June 2023 will be held on the Glasnevin Campus rather than the St. Patrick's Campus. The Chair informed the Board that this is to accommodate those members who are due to meet with the Peer Review Group for the Quality Review of the Office of the Vice President Academic Affairs on the same date.
