The Chair <u>noted</u> that there are differences across the University in where the structured doctoral pathway documents are hosted and informed members that these should be hosted on the relevant faculty (research) webpage, particularly due to ownership and University accessibility requirements.

The Chair informed members that the updated guidelines on GTE Modules and Doctoral Pathways will ensure alignment between GRSB and Faculty Office/School processes for revising and approving Doctoral Pathways. The Chair also informed members that the current template for Doctoral Pathways will have to be changed to ensure it meets the University accessibility requirements, while also allowing Faculties/Schools to record the annual changes to the pathways, to aid their approval and to capture the information required for online publication.

5. Change to PGR6 Form

The Chair set out the rationale for including specific prompts in Section B3, which are intended to ensure that the Internal Examiner and External Examiner(s) provide sufficient detail on the examination and that there is greater consistency in PGR6 Forms across the Faculties.

The Board recommended the following changes to the prompts:

- Inclusion of a contextual statement at the beginning of Section B3, e.g., "Please use
 the prompts below to provide details on the viva voce examination, including any
 relevant additional information that is not related these prompts."
- In Prompt A, replace the strikethrough text with the underlined text: "Please indicate if describe how the candidate demonstrated that the thesis presented is their own work...".
- In Prompt B, replace the strikethrough text with the underlined text: "Please indicate if describe how the candidate demonstrated that they had an adequate in depth understanding of the research topic...".
- In Prompt C, delete the strikethrough text: "Please outline why the research, provides meets, or fails to provide, a satisfactory basis to meet the award level that the thesis was submitted for:".
- Inclusion of an additional prompt that will allow examiners to set out if and how the candidate demonstrated the ability to defend their chosen methodology.
- Inclusion of an additional prompt that will allow examiners to provide other relevant feedback regarding the examination.

<u>Decision Deferred</u> – It was <u>noted</u> that members will have a further opportunity to review the proposed wording for the prompts to be included in Section B3 and to recommend revisions as necessary. The revised wording will be considered at the next meeting of GRSB.
