SECTION A: Minutes and related issues

1. Adoption of agenda

The agenda was adopted subject to the inclusion of one additional submission under Item 4, two additional submissions under Item 5, eleven additional submissions under Item 6, one additional submission under Item 7 and one submission under Item 13.

2. Minutes of the meeting of 2 July 2009 (for noting only; already confirmed)

Signed by the Chair.

3. Matters arising from the minutes

3.1 Noted that Professor Murphy was progressing the revision of *Academic Regulations for Postgraduate Degrees by Research and Thesis* and would make a draft available to the GSB, the working group of the GSB which had initially discussed the

- revisions, the Research Advisory Panel and the Faculty Research Committees. (Item 3.1)
- 3.2** Noted that Professor Murphy had met Ms Barbara McConalogue, Director of Information Systems and Services, to discuss a range of issues including online form completion, digital signatures and online support for students in remote locations, and that it was planned to hold further discussions on these matters with ISS and Registry. (Item 3.3) (See also Item 5 below.)
- 3.3** Noted that, in the case of a student who had not been confirmed on the PhD register, had appealed this decision and had had the appeal upheld, a resubmission had taken place and the decision had been made again not to permit confirmation on the PhD register. (Item 3.5) (See also Item 5.13 below.)
- 3.4** Noted that the Graduate Research Office would make available hard copies of the *IUQB National Guidelines of Good Practice in the Organisation of PhD Programmes in Irish Higher Education* and that it was intended to create a link from the GRO home page to the IUQB website. (Item 3.8)
- 3.5** Noted, in respect of the Quality Improvement Plan following the quality review of the postgraduate experience, that it was planned to support the training of supervisors as well as graduate training initiatives. Professor Murphy is to meet Training and Development staff from the Human Resources Office in relation to the former issue. Noted that, while it is usual for supervisory training to be undertaken by new supervisors, it might also be of considerable benefit to established supervisors. Professor Murphy outlined some of the features of the Peer Review Group report: there was considerable emphasis on the student experience and the importance of ensuring that a holistic approach was taken to this, with advance information being made available to students as to what they might expect from the experience of being a postgraduate student; it was recommended that a ‘champion’ for taught postgraduate students be appointed, and the possibility of progressing this matter was being investigated by the Office of the Vice-President for Learning Innovation; a submission in relation to the recommendations generally is to be made to Budget Committee. (Item 3.9)
- 3.6** Noted that reference had also been made in the QuIP to the resourcing issues attaching to the use of PAC for research student applications and that Professor Murphy was due to meet Ms Phylomena McMorrow, Director of Registry, to discuss these issues. Professor Murphy will also establish with Ms McMorrow whether or not PAC can be used for international student applications. Noted that it would be very important to ensure that, if PAC were used, it would still be necessary for a potential applicant to contact the relevant

- School in advance to discuss the proposed research and no offer of a place could be made without this step having taken place. (Item 3.10)
- 3.7** Noted that St Patrick's College was also discussing the option of using PAC for research student applications. (Item 3.11)
- 3.8** Noted that it had been agreed to attribute five credits to the Qualitative Research Summer School in the School of Nursing but that some further discussion on procedures would be required in the more general context of approval processes for graduate training elements. (Item 3.12) (See also Item 10 below.)
- 3.9** Noted that Professor Murphy had contacted a number of Schools to convey the concern of the GSB about the long interval, in the case of some students, between initial registration on the Master's register and submission for transfer to the PhD register. Noted that it would be desirable to have an automated system for identifying students who are due for transfer to (or confirmation on) the PhD register and that it was hoped the introduction of ITS Version 14 would provide a facility for this. Agreed that this matter should be discussed at the meeting between Professor Murphy, ISS and Registry referred to at Item 3.2 above. Agreed that the revised *Academic Regulations for Postgraduate Degrees by Research and Thesis* should be specific about the need for timely transfer/confirmation. (Items 4.1, 4.2 and 4.6)
- 3.10** Noted, in the case of a student whose application for transfer to the PhD register had not yet been approved, that discussions with the School were ongoing. (Item 4.5)
- 3.11** Noted, in the case of eight students whose applications for confirmation on the PhD register had not yet been approved, that discussions with the School were ongoing. (Items 5.5, 5.6, 5.7, 5.8, 5.9, 5.10, 5.11, 5.12)
- 3.12** Noted, in relation to concerns raised about the standard of research students' academic writing skills, that Professor Murphy had discussed with Dr Claire Bohan, Director of Student Support and Development, the possibility of making tuition in writing skills available to some students through DCU Language Services and that he would hold further discussions with her about the needs of international students in terms of writing skills. (Item 5)
- 3.13** Noted that the revised *Academic Regulations for Postgraduate Degrees by Research and Thesis* would need to be more specific than the current version in respect of eligibility to act as internal and external examiner. Agreed that postdoctoral researchers should act as internal examiners only in exceptional circumstances and should never act if they report to the supervisor. (Item 6.14)

- 3.14 Noted that Professor Murphy had conveyed to the Royal Irish Academy of Music the concern of the GSB that advance permission had not been sought for early submission by a student on a taught doctoral programme. Noted none the less that the student in question had been successful at examination and that she would be the first student to graduate from the university with a taught doctoral degree. (Item 6.24)
- 3.15 Noted that it had been confirmed that a student referred to on an R-103 (change of supervisory arrangements) form was on the PhD track. (Item 7.3)
- 3.16 A request in respect of a change of supervisory arrangements was approved. (Item 7.6)
- 3.17 Agreed to await developments in the case of a request for a change of supervisory arrangements. (Item 7.7)
- 3.18 Noted that the possibility of classifying research Master's degrees would be discussed at a future meeting of the GSB. (Item 10)

Approved. Agreed that the Chair would discuss the intention with Professor David Jacobson, Associate Dean for Research in Dublin City University Business School, and would inform the GSB of the outcome of the discussion. Noted also that it would be helpful to stipulate a maximum time period for completion of a PhD. Agreed that this matter and the question of readmission of a student to the PhD-track register would be considered in the context of the review of *Academic Regulations for Postgraduate Degrees by Research and Thesis* (see Item 3.1 above).

The importance of clear procedures and consistent practice in these matters was noted. Agreed that they should be considered in the

context of the review of *Academic Regulations for Postgraduate Degrees by Research and Thesis* (see Item 3.1 above). Agreed also that the Chair would raise with the Director of Information Systems and Services the tendency for forms to be completed manually and request advice as to mechanisms that might be put in place to encourage electronic completion. (See also Item 3.2 above.)

10. Approval processes for graduate training elements

Professor Murphy summarised developments to date in respect of these processes, noting that detailed information would be made available to the 5 November 2009 meeting of the GSB.

11. Revised graduate research forms

- 11.1** The revised, combined PGR3 and PGR11 form was approved. It was noted with approval that, from now on, this combined form would cover both requests for transfer to, and requests for confirmation on, the PhD register, thus eliminating the need for staff to select from between two forms. The new form is to be called PGR3.
- 11.2** The revised PGR4 form (notification of intention to submit thesis for examination) was approved subject to the inclusion of a stipulation, beside the request to list five publications by the nominated external examiner of particular relevance to the area covered by the candidate's research, that full citations must be provided in all cases and that failure to do this would mean the form could not be considered.
- 11.3** The revised R103 form (request for change of supervisory arrangements) was approved.
- 11.4** Ms Devereux is to notify the relevant staff of the revised forms. The Chair thanked Ms Devereux for her work in revising the forms.

12. Presentation by the Library on E-theses and Doras

- 12.1** Ms Rachel Hill, Institutional Repository Manager in the Library, made a presentation on E-theses and Doras, the online website for DCU publications and outputs, noting that Doras was a free open-access service which aimed to promote research carried out in the university.
- 12.2** In the course of the ensuing discussion, the following were noted:
- it is very important that students are made aware of issues relating to copyright at an early stage in their research
 - the fact that responsibility for uploading the thesis to Doras rests with the supervisor may raise issues relating to verification of compatibility between the printed and the electronic versions
 - there are also issues relating to restriction of access to theses, with potential tensions between conflicting needs, notably confidentiality and commercialisation
 - amendments to online theses following graduation are not permitted in any circumstances
 - the issue arises of uploading theses written before Doras and similar systems became available; related issues include the fact that students would not have given permission for this to be done, and the importance of quality control (in

particular, ensuring that the version uploaded is the final version as approved by means of the examination process); Ms Hill noted that the British Library is operating a system of contacting graduates, to the extent possible, by such means as newsletters, to ask their permission to upload theses; if, however, after a certain period has elapsed, the Library has not heard from a student, it uploads the thesis in any event

- there can be no control over who downloads theses or what use they make of them once downloaded.

12.3 Noted that a presentation from the Library on copyright would be useful.

12.4 Agreed that Professor Murphy and Dr Brabazon would discuss copyright and related issues, would seek advice from Professor Alan Smeaton of the School of Computing, and would report to a future meeting of the GSB.

12.5 Professor Murphy expressed appreciation to Ms Hill, on behalf of the GSB, for her presentation.

13. Any other business

Professor Murphy alluded to discussions which were taking place at Budget Committee with a view to making funding available for capacity-building with regard to graduate research, including a scholarship scheme. The importance of continuity of funding and of having an easily-recognisable Graduate School 'brand' was noted. Agreed that the needs of the linked colleges would be factored into the discussions. Agreed that Professor Murphy would provide the GSB with updated information on these matters at the meeting of 5 November 2009.
