Project Overview

Building upon existing pioneering developments in micro-credentials, this post offers an exciting opportunity for the successful candidate to play a central role in the rollout of DCU's micro-credentialing strategy. Under the direction of the Director of Micro-credentials Strategy and Innovation and the MicroCreds Institutional Project Manager, you will work closely with project staff and other partners to achieve all project goals. You will also collaborate with colleagues from the MicroCreds IUA project team, DCU Studio colleagues, MicroCreds personnel in partner institutions and in other micro-credentialing initiatives.
