Role Profile

The School of Law and Government intends to appoint a new Lecturer in International to begin on 1 August 2023. The successful candidate will be expected to teach a number of modules as agreed with the Head of School. Duties and Responsibilities

The duties and responsibilities of the position include, but are not restricted to, the following:

Teaching and Learning

The successful candidate will be required to contribute to the development, teaching, assessment, and administration of our modules across a range of undergraduate and postgraduate programmes.

- Include the design and delivery of modules on International Relations and/or area studies to the School's suite of postgraduate and undergraduate programmes.
- Supervise undergraduate and taught postgraduate thesis.
- Contribute to the wider teaching of the School, as required by the Head of School.

Research and Scholarship

The successful candidate will be committed to high-quality research and publication in the field of public policy on an individual and a collaborative basis. The successful candidate will be expected to participate in the following:

- Publish articles in leading peer-review journals and/or books with high-profile publishers.
- Contribute to the development and support of research initiatives with the School Law and Government and the wider university.

Service and Contribution to the University and Society

Activities taken on the successful candidate's own initiative, or allocated by the Head of School, may include:

Applicants for the position should have or be near completion a PhD in a relevant area of social sciences. The successful candidate will have some experience of university teaching at lecturer/assistant professor level, will be able to convincingly demonstrate a strong commitment to academic research and will have a track-record of international peer-reviewed publications or demonstrate potential for same. The successful candidate should be capable of working in a team and contributing to developing the teaching and research agenda within the School.
