Role Profile

The School is seeking to recruit at the level of Associate Professor in Community Health. The appointee will be expected to provide leadership and innovation in teaching and learning, research and scholarship and community/civic engagement. They will be expected to contribute to teaching, curriculum development, research, and academic administration in the School. The appointee will be expected to contribute directly to undergraduate and postgraduate programmes through research-led teaching, student mentoring and support, and supervision of student projects and research. The appointee will also be expected to attract research funding and lead research projects in community health and contribute to advancing the Schools research agenda. The appointee will engage productively with relevant University departments and working groups and will play an important community/civic engagement role with wider communities and societies. The post is based on the Glasnevin Campus and the candidate will report to the Head of School.

Duties and Responsibilities

The duties and responsibilities of the position include, but are not restricted to, the following:

Teaching and Learning

To contribute to the teaching and learning activity of the School by:

- Coordinating and delivering modules in a manner consistent with the highest academic standards;
- Using a wide range of teaching and assessment methodologies which foster a deep approach to learning and which equip students with the skills and attributes needed to be lifelong learners;
- Leading proactively to enhance and enrich existing modules and programmes;
- Leading the design and development of new modules and programmes;
- Providing research supervision for taught postgraduate students.

Research and Scholarship

To contribute to the research agenda and profile of the School by:

- Having a clearly established research programme and research profile development plans
- Publishing new ideas and findings in high impact international journals
- Achieving measurable impact via citations
- Seeking and attracting research income to drive research initiatives;
- Leading research activities such as conferences, seminars etc.

- Attracting and supervising and assessing postgraduate research students
- Contributing to the research culture and environment in the School and, where appropriate, working collaboratively on research initiatives.

Service and Contribution to the University and Society

To contribute to the leadership, management and administration of the School by:

- Contributing proactively to relevant School and University committees, working groups and meetings;
- Leading and actively engaging in accreditation-related activities;
- Undertaking and delivering management and school roles to a high standard;
- Representing the School in activities such as marketing and student recruitment;
- Developing relationships with stakeholders within and outside the University;
- Engaging in and leading external academic, enterprise, professional, public sector and community activities to enhance the reputation and impact of the School.

Qualifications and Experience

Minimum criteria:

- Applicants will be qualified to post-graduate level and must have completed a PhD/Doctorate in a field relevant to Community Health
- A minimum of three years' relevant undergraduate and postgraduate teaching and learning experience at University level is required

In addition to the above, the candidate should also:

- Demonstrate evidence of development of new modules, programmes or curricula, especially when driven by new disciplinary and/or research developments
- Have research portfolio with a track record of leading research teams and of attracting external peer-reviewed competitively-won national/international funding.
- Have evidence of a substantial and sustained track record of peer-reviewed publications in leading international journals
- Demonstrate a track record of research supervision and successful completion of PhDs (or equivalent doctoral degrees) and postdoctoral researchers
- Demonstrate substantial involvement in developing interdisciplinary and intersectoral research networks and partnerships, including public involvement, that deliver defined outcomes and impact into societal benefit is required
- Have a demonstrable record of service to School, Faculty, and University strategic objectives is also required
- Have excellent interpersonal and communication skills, along with evidence of successful teamwork and a collaborative and collegial approach.
- Research in the field of health inequalities and social exclusion, including designing, implementing and evaluating interventions to improve community health engagement and social wellbeing is desirable.
