The Insight SFI Research Centre for Data Analytics (<http://www.insight-centre.org>) is an SFI funded Research Centre which brings together researchers from University College Dublin, NUI Galway, University College Cork, and Dublin City University, as well as other partner institutions, Trinity College Dublin (TCD), University of Limerick (UL), Maynooth University (MU) and Tyndall

National Institute. It creates a critical mass of more than 400 researchers from Ireland's leading ICT clusters to carry out research on a new generation of data analytics technologies in a number of key application domain areas, such as Health and Human Performance, Smart Communities, Internet of Things, Enterprise and Services and Sustainability and Operations.

The €150m Centre is funded by Science Foundation Ireland and a wide range of industry and European Union partners. Insight's research focus encompasses a broad range of data analytics technologies from machine learning, decision analytics and social network analysis to linked data, recommender systems and the sensor web. Background

The Role

The successful candidate will assume the post of postdoctoral researcher in the Insight SFI Research Centre for Data Analytics, DCU, in collaboration with UPMC Sports Surgery Clinic (SSC).

The successful candidate will be embedded in the UPMC SSC to demonstrate the benefits of digital transformation for both day-to-day operations in enhancing patient care and the ability of digital transformation to enhance research by providing access to high-quality datasets and to deliver a roadmap to digital transformation to the UPMC SSC. This involves a comprehensive analysis of the data landscape at present within the UPMC SSC. Through consultations with practitioners and staff, the successful candidate will document the existing data sources and workflows within the UPMC SSC to provide an overview of data availability and use within the UPMC SSC. This will be presented as a series of data dictionaries. The successful candidate will identify all relevant stakeholders within the SSC involved in patient care and satisfaction, research and reporting. All stakeholders, their interactions, responsibilities, perspectives and requirements will be documented to ensure the scope of operations and use of datasets within the SSC are thoroughly captured. The candidate will examine the state of the art in digital transformation and the medical domain to aid the SSC in defining their vision for digital transformation.

Principal Duties and Responsibilities

- Conduct a programme of research on the existing data landscape, the efficacy of the pilot projects, and the state of the art, and produce a roadmap which will align the data infrastructure and capabilities of the SSC with the vision for digital transformation, addressing gaps within the data landscape and potential digital solutions.
- Produce top quality journal and conference publications, in collaboration with the PIs.
- Participate in Insight Centre activities, including industry showcases, annual reviews and industry and agency visits to the Insight labs.
- Carry out administrative work associated with the programme of research as necessary.
- Other tasks relevant to successfully implementing the assigned research programme.
- Liaise with both external and internal stakeholders, including academics, undergraduate and postgraduate students, external supervisors and host placement schools.
- Preparation of project outputs, interim and final reports as required by the project schedule.
- Deliver research outputs according to project schedules.
- Other tasks relevant to successfully implementing the assigned research programme.
- Attend and present results at project progress meetings.
- Identify opportunities for collaboration with industry partners and funding organisations.
- Identify and promote potential areas of inter-disciplinary and multi-disciplinary collaboration within the Insight Centre and the University.
- Maintain a good understanding of the University's policies as they relate to research e.g. governance, data management, ethics and intellectual property

Qualifications, Skills and Experience Required

The successful individual should have a PhD in Computer Science, Engineering, Mathematics or a cognate discipline.

- Excellent written and verbal communication and interpersonal skills.

- Proven ability to prioritise workload and work to strict deadlines.

Candidates will be assessed on the following competencies:

Discipline knowledge and Research skills – Demonstrates knowledge of a research discipline and the ability to conduct a specific programme of research within that discipline.

Understanding the Research Environment – Demonstrates an awareness of the research environment (for example funding bodies) and the ability to contribute to grant applications.

Communicating Research – Demonstrates the ability to communicate their research with their peers and the wider research community (for example presenting at conferences and publishing research in relevant journals) and the potential to teach and tutor students.

Managing & Leadership skills - Demonstrates the potential to manage a research project including the supervision of undergraduate students.

Essential Training

The postholder will be required to undertake the following essential compliance training: Orientation, Health & Safety, Data Protection (GDPR) and all Cyber Security Awareness Training. Other training may need to be undertaken when required.
