The IT Security Engineer will report to the Deputy Director of ISS and work with the Senior IT Security Engineer, within the Engineering & Innovation Team, to monitor and manage the operation of security systems and best practice across the university's IT environment. The post-holder will participate in security related service management processes (security incident, change and problem management) and will participate in the planning, design, enforcement and review of security controls which protect the integrity of DCU digital assets.
