Applicants for the positions must hold an honours degree, should be qualified to a post-graduate level, and have completed a doctoral qualification in law. The successful applicant will have an excellent research and publications record. They must have at least three years' relevant experience, with appropriate higher-level teaching experience. The successful applicant I should be capable of working in a team and contributing to developing the teaching and research agenda within the School, as well as promoting School's fund-raising activities through grant applications. We are interested in applicants with all research specialisms, but have particular teaching requirements in private law and economic law, and therefore are interested in applicants with a willingness to do some teaching in those areas, while also teaching from their research specialisation and interests.
