# Assistant Professor in Law (Two Posts) School of Law and Government Faculty of Humanities and Social Sciences Fixed term 3-year contract

#### Overview

## The School of Law and Government

The School of Law and Government offers programmes in Law both at undergraduate and graduate level, including a BCL (recognised by the Honorable Society of King's Inns as an approved law degree), a BA in Economics, Politics and Law, law as a Joint Honours BA subject, a LLM, and a PhD programme. It also offers a MA in Data Protection and Privacy Law jointly with the School of Computing and a MA in European Law and Policy. The School has a particular interest in socio-legal studies and promotes interdisciplinary research, through the DCU Brexit Institute and Law Research Centre. The School is committed to high quality research, expects its staff to publish regularly in leading journals and supports its staff in such work. We have led research programmes supported by the Irish Research Council, the EU and other national and international funders.

#### **Role Profile**

The School of Law and Government intends to appoint two Assistant Professors in Law, to begin on 1 September 2021. We especially welcome candidates with a strong international research profile. The successful candidates will be expected to teach across our law programmes. The School also offers opportunities for candidates to teach within their own area of research specialisation and to supervise PhD candidates. The School is committed to high quality research, expects its staff to publish regularly in leading journals and with leading university presses and supports its staff in such work.

#### **Duties and Responsibilities**

The duties and responsibilities of the position include, but are not restricted to, the following:

#### **Teaching and Learning**

The successful candidates will be required to contribute to the development, teaching, assessment, and administration of our modules across a range of undergraduate and postgraduate programmes:

- To include the design and delivery of modules on the School's suite of law programmes,
- The design and delivery of other interdisciplinary modules, where appropriate,
- Supporting and evaluating students on placement visits and writing reports,
- Contributing to the design, development, and management of future programmes and other developments in the field of law,
- Supervising undergraduate and postgraduate theses, and
- Contributing to the wider teaching of the School, as required by the Head.

#### Research and Scholarship

The successful candidates will be committed to high-quality research and publication in the field of public policy on an individual and a collaborative basis. The successful candidate will be expected to:

- Publish articles in leading peer-review journals and/or books with high-profile publishers;
- Assist and Develop research initiatives with the School Law and Government and the wider university;
- Apply for grants to contribute to the School's research agenda; and
- Attract and supervise high-calibre PhD students.

# Service and Contribution to University and Society

Activities taken on the successful candidates' own initiative, or allocated by the Head of School, may include:

- Engaging with the legal profession, policy-makers and the media,
- Participating in school and university meetings,
- Representing the School in marketing and the recruitment of students,
- Developing relationships with stakeholders within and outside the University.

## **Qualifications and Experience**

Applicants for the positions must hold an honours degree, should be qualified to a post-graduate level, and have completed a doctoral qualification in law. The successful individual will have an excellent research and publications record. They must have at least three years' relevant experience, with appropriate higher-level teaching experience. The successful individual should be capable of working in a team and contributing to developing the teaching and research agenda within the School, as well as supporting the School's fund-raising activities through grant applications. We are interested in applicants with all research specialisms, but have particular teaching requirements in private law and economic law, and therefore are interested in applicants with a willingness to do some teaching in those areas, while also teaching from their research specialisation and interests.

# **Mandatory training**

The postholders will be required to undertake the following mandatory compliance training: Orientation, Health & Safety, and Data Protection (GDPR). Other training may need to be undertaken when appropriate
