Applicants must have a relevant honours degree (NFQ Level 8), preferably a 1.1 or 2.1 honour, and have previous teaching and research experience. It is highly desirable that applicants have a PhD, alternatively, they must have commenced a PhD or be able to clearly demonstrate a strong commitment to pursuing a PhD. It is highly desirable for applicants to hold a professional accounting qualification and have a relevant postgraduate award. Relevant industry experience is welcomed.

We are seeking applicants who have a well-defined research plan and have the capability to publish in high impact international journals. Applicants should have (or be able to develop) international networks and collaborations. Applicants should also demonstrate excellent interpersonal and communication skills consistent with the highest quality of teaching and learning, along with evidence of successful teamwork and a collegial approach.

The successful applicant will have the opportunity to play an important role in the further development of the School's national and international reputation, and to make a significant contribution to the research activity and industry engagement of the School and to the design, delivery and management of programmes at undergraduate, postgraduate and executive levels.
