4. Graduate researcher development

4.1 Graduate Skills Sessions, December 2024 – January 2025

The Graduate Studies Office (GSO) provided a list of the Graduate Skills Sessions that will be delivered in December 2024 and January 2025. The Chair requested the Associate Deans for Research (ADRs) to promote these sessions in their respective faculties.

The Chair informed the Board that the schedule of Graduates Skills Session for Semester 2 of the current academic year will be made available via the GSO website in the coming weeks.

5. Report from GRSB Appeals Standing Committee

The Chair introduced the report from the Graduate Research Studies Board (GRSB) Appeals Standing Committee, which met on 6 November 2024 to consider an appeal submitted by a PhD student.

The Chair set out the context of the appeal and the two grounds upon which the appeal was being sought. She informed the Board that the student appealed a decision not to allow progression to the next year of study, on the grounds that:

- i. there were extenuating circumstances that the supervisory panel or examiners were not aware of because the student was unable or, for valid reasons, unwilling to divulge before the decision was made and which would have made a real and substantial difference to that decision.
- ii. there is evidence of a material administrative error or a material irregularity in assessment procedures which has made a real and substantial difference to the decision of the supervisory panel or the outcome of an examination.

The Committee decided to uphold the appeal on both grounds cited by the student.

It was agreed by the Committee that the extenuating circumstances, if disclosed to the principal supervisors in advance of the Annual Progress Review (APR) meeting on 14 June 2024, would have made a real and substantial difference to the decision that was made, i.e. requiring the student to complete considerable revisions to her methodology chapter and prepare for a further APR meeting during a very challenging period.

It was also agreed by the Committee that there is evidence of a material irregularity in the assessment procedures relating to APR which made a real and substantial difference to the decision of the supervisory panel.

The decision of GRSB Appeals Standing Committee was **<u>approved</u>**. The Chair informed the Board that the outcome is that the candidate should be permitted to progress to the next year of study and to register in the current academic year.

It was agreed that the Secretary will issue the formal outcome letter to the student and will prepare a report for Academic Council, which will be submitted for noting at its meeting on 5 February 2025. It was further agreed that the Chair will inform the relevant Head of School of the outcome and will arrange to meet them along with the ADR to discuss the issues that were raised by GRSB Standing Committee during its consideration of the appeal.

- 11.2 Dr Conor Brennan raised a query regarding the letter to be issued to External Supervisors, which was approved by GRSB on 17 October 2024 (GRSB2024/A7/7). At the Faculty Management Board in the Faculty of Engineering and Computing, the Heads of School raised a concern about being responsible for issuing these letters.

The Chair confirmed that the intention is to establish a standardised practice in each faculty and that responsibility for issuing these letters does not necessarily have to reside with the Head of School. The Chair suggested that the Principal Supervisor should issue this letter in the first instance, with support from the research administrator or faculty administrative staff where possible.
