WHAT IS EUSRexcel?

The EUSRexcel (Towards a European University Social Responsibility Excellence Award) project is an initiative in which HE institutions and research organisations worked together to develop a common framework of criteria and indicators of Social Responsibility in the field of Higher Education. Through research and training, this project raises awareness among University management and staff to institutionalize University Social Responsibility (USR) recognizing it formally in relevant quality indicators. This project was conceived after identifying the need for a common framework that measures and certifies Social Responsibility in the higher education sector, supporting institutions in meeting the EC agenda on Smart, Sustainable and Inclusive growth, which includes social responsibility.

This project comprised two key intellectual outputs. The first phase focused on building a theorical framework to develop the model of reference to identify and harmonize the key USR indicators. The second phase centered on creating a USR Online Evaluation Tool and the Design of a USR Quality Certification:

Funded by ERASMUS+, this project was carried out over 36 months, from September 2018 to August 2021 with the support of CONEXX-EU (Belgium), The University of Applied Sciences VAMK-Vaasa (Finland), Dublin City University (Ireland), Innovation Training Centre (Spain), The University of La Sapienza (Italy), the University of Girona (Spain) and a number of associated partners from the academic sector across Europe to create a network of universities with a USR quality certification.

The relevance of the European framework of USR harmonized indicators resides on the provision of a universal measurement tool for management boards at universities to assess their commitment to USR, and the creation of a new USR Quality Seal to reward higher education institutions based on their performance in USR.















PROJECT RESULTS

The mobilization of expertise from our key and associated partners have contributed to raising awareness amid the participating universities and external stakeholders such as management boards, administrative staff, academics and researchers that collaborated in this initiative to identify the strengths and weaknesses in terms of socially responsible involvement within their sphere of influence. Furthermore, the work undertaken over 36 months resulted in the creation of a EUSRexcel guide, an Online Self Evaluation tool on USR, a Users Handbook, a Table for Evaluation, a Good practices illustration, Staff Training material, an External Evaluation Board and a USR Quality Seal that integrate a common framework that can be easily used by European universities and with this, promote a harmonization and consciousness of the importance of the Social responsibility within higher education institutions.
