SECTION A: MINUTES RELATED ISSUES

1. Adoption of the agenda

2. Minutes of the meeting of 10 September 2020

The minutes of 10 September 2020 were <u>approved</u>. It was noted that formal minutes would be signed at a later date.

- 3.1 It was <u>noted</u> that an issue had arisen with respect to the approval of the BSc in Marketing, Innovation and Technology programme regulations which also impacts on programme regulations for other first year business programmes. The Chair indicated that he would discuss the item with the Associate Dean for Teaching and Learning in DCUBS with a view to finding a solution to the issue which ensured the programme regulations were in line with Marks and Standards (Item 5.2.1).
- 3.2 It was <u>noted</u> that a revised nomination for an external examiner for Open Education is on the agenda (4.1.3) of this meeting (Item 4.1.6).
- 3.3 It was <u>noted</u> that clarification with respect to the registration details of a student applying to be re-admitted to the Professional Certificate/Diploma in Special and Inclusive Education was provided and the student was deemed eligible for re-admission (Item 5.3.1).

3.4 It was <u>noted</u> that changes recommended by USC to the Bachelor of Education programme regulations were completed (Item 5.3.4).

- 3.5 It was <u>noted</u> that a nomination for an external examiner for the Common Entry in Actuarial Mathematics programme was <u>approved</u> by Chair's Action, 4 November 2020 (Item 4.1.3).
- 3.6 It was <u>noted</u> that a legacy re-admission application for entry onto the BSc in Information Technology and Information Systems in Open Education was <u>approved</u> by Chair's Action 23 September 2020.
- 3.7 It was <u>noted</u> that a legacy re-admission application for entry onto the BA in Humanities in Open Education was <u>approved</u> by Chair's Action 23 September 2020.
- 3.8 It was <u>noted</u> that a minor amendment to the programme regulations for the BSc in Environmental Science and Technology was <u>approved</u> by Chair's Action, 23 September 2020.

<u>Approved</u>. It was <u>noted</u> that the student will re-enter the programme in semester two, January 2021 and will complete the programme in the academic year 2020-2021.

SECTION C: NON FACULTY SPECIFIC ITEMS

6. Academic arrangements for the academic year 2020-21

The Chair outlined the background to the document as circulated noting that the OVPAA team had collated and reviewed academic regulatory changes made in 2019-2020 in response to Covid-19 and under the provision for a Force Majeure event, documented in Marks and Standard. The document summarised the regulatory changes and the decision on their continuation or otherwise in 2020-2021, in light of that review.

The Chair highlighted the following arrangements that would continue for the academic year 2020-2021:

 The retention of the Duolingo English test for admissions purposes for non-native speaks of English

- No on campus written tests in 2020-2021. There may be some exceptions made but these will require prior approval
- Suspension of Anonymous marking
- Amendments to duration of examinations because of the nature of online exams
- The set-up of an exam support centre for each diet of exams
- The review by external examiners of all significant assessments
- External examiners will not be required to attend Progression and Award Boards
- Documentation supporting extenuating circumstances, postponements and appeals will
 not be required. It was noted that the relevant forms are being modified to enable the
 gathering of more detail from students.
- The processing of exam outcomes will continue as per 2019-2020 for 2020-2021 and thereafter will be reviewed (e.g. PABs conducted through Zoom, reduced membership of PABs).

The following will not be retained:

- Accommodations on module marks and award classifications introduced in 2019-2020 due to the sudden and unexpected shift to remote learning
- The rule relating to the minimum mark of 40% for students retaking modules will not be retained in 2020- 2021, but will be reconsidered by USC when it is possible to implement operationally.

The document was <u>noted</u> by University Standards Committee. It was <u>noted</u> that students had provided positive feedback on the early availability of information so that they could plan their academic year.

The Director of Registry brought the following to the attention of USC. Due to the change from formal attended examinations to online exams, in some cases external examiners were not being provided with the opportunity to review MCQ examinations, as the MCQs were being developed directly on Loop, rather than being provided through Guru, where external examiners have access. It was noted that the linking between Loop and Guru was currently being investigated. It was noted too that practice exists whereby some schools provide a representative sample of questions to external examiners. The Chair indicated that where external examiners are not currently being facilitated, they should be enabled to review a representative paper, particularly where it represents a substantial element of assessment.

7. Programme Regulation Template 2021-2022

The Secretary informed USC that there were no changes to the programme regulations template for 2021-2022. She indicated that it was intended to follow the usual timeframe and the deadline for submission of regulations which would be 23 April 2021, for approval at the 20 May 2021 meeting of USC.
