Relationships

The Role

The appointee will be expected to assist the School in implementing an innovative curriculum project, specifically;

- developing and delivering a new bachelors programme, BSc in Digital Business and Innovation, ensuring an industry engaged, research-led approach, integration of challenge based learning, digital tools and hybrid delivery.
- broader implementation of teaching approaches into other target programmes in the school, and
- engaging with university-wide elements of the initiative including cross faculty assistance, project evaluation and reporting.

The role includes teaching, student mentoring and supervision of taught projects and research.

Applicant Requirements

Candidates must have a PhD (or be close to submitting a PhD for examination) in Innovation or a related discipline, with a focus on innovation, management, and sustainability (for example Sustainable Innovation, Sustainable Management, Digital Innovation) and have a strong academic record. Previous teaching and research experience is required and a relevant professional qualification, where appropriate, is welcomed. Relevant industry and applied experience is also desirable.

We are seeking candidates who both have a well-defined research plan and have the capability to publish in high impact international journals. Candidates should have (or be able to develop) international networks and collaborations. Candidates should also demonstrate excellent interpersonal and communication skills consistent with the highest quality of teaching and learning, along with evidence of successful teamwork and a collegial approach.

The successful candidate will have the opportunity to play an important role in the further development of the School's national and international reputation, and to make a significant contribution to the research activity and industry engagement of the School and to the design, delivery and management of programmes at undergraduate, postgraduate and executive levels.
