Programme Title: Bachelor of Education

Programme Code: DC002/DC003

Offering Type: Full-time (01)

1. Programme-specific rules and requirements

The final degree award is calculated on performance in years 2, 3 and 4, in the ratio 20:40:40 respectively. The mark to be used for each year is the overall weighted average based on the first attempt at the relevant approved modules. In cases where this overall weighted average is less than 40% and the student has subsequently successfully completed the requisite credits, a mark of 40% will be used. The School Placement module in year 1 (SP1) and is graded on a pass/fail basis. Marks are awarded in years 2 (SP2), 3 (SP3) and 4 (SP4).

2. Derogations from Marks & Standards

[Ref: DCU M&S V.2015.1, Item 6.2.2]: Compensation is not permitted in the Literacy, Teagasc na Gaeilge, Mathematics and Gaeilge components of the following modules: ED1003, ED1006, ED282, ED285, ED346, ED347, ED443 and ED444.¹ Compensation is not permitted in the Reflection element of the following modules ED1008 and ED286.²

3. Progression

Normally, students must successfully have completed a minimum of 60 credits in a study period in order to progress to the next study period. Students will not be permitted to 'carry' modules under any circumstances.

There is no re-sit opportunity for School Placement (SP1, SP2, SP3, and SP4). A student who is required to repeat School Placement may normally repeat it once only¹.

A student who wishes to take a First year Foundations in Humanities and Science subject as his/her Major Specialism in Second year may not normally do so unless he/she has attained a mark of at least 40% in that subject in First year. Where the number of places on a Second year Major Specialism is restricted, places will be allocated in order of merit on the basis of the results of the first sitting of the corresponding First year examination.

4. Compensation

Compensation may apply, within the regulations specified in Marks and Standards, to all modules except the following [Ref: DCU M&S V.2015.1, Item 7.2.6]

Re-Sit Category 3: No re-sit is available for the continuous assessment component.
