# 1. Programme-specific rules and requirements

#### 1.1 Calculation of Precision Mark

The precision mark is normally defined as the overall weighted average for the first full presentation of marks (Marks and Standards, Item 7.1.3). Modules are normally weighted proportionately according to their credit value. As there are exceptions on this programme, listed below are the proportional weightings in percentage terms of each module for the calculation of the precision mark.

- 1.2 Students must attend 85% of lectures in each module [Ref.: DCU M&S, Item 3.1.2; Teaching Council]
- 1.3 Students can be withdrawn from the programme for serious breach of Code of Behaviour [Ref.: Sec. 41 Teaching Council Act 2001]
- 1.4 Programme requirements pertaining to School Placements:
  - 1.4.1 Students must maintain a placement in order to remain on the programme [Ref.: Teaching Council]



- 1.4.2 All students must complete a minimum of 100 hours of actual teaching with a class group of no less than 15 students in a second-level school with students between the ages of 12 and 18 years. Students must teach a subject from the second-level curriculum. Incoming students (2014-2015) should also spend at least another 200 hours in the placement under the mentorship of experienced staff and observing school life, teaching and extra-curricular activities [Ref.: Teaching Council].
  - It may be necessary for School Placement Supervisions to take place outside of the normal lecture period of each semester during the examination periods in January and May.
- 1.4.3 In Year 1, module ES438 School Placement will be spread across Semester 1 and Semester 2 (2 hours teaching per week) [Ref.: DCU M&S, Item 2.2.1; Teaching Council]
- 1.4.4 In Year 2, module ES439 School Placement 2 will be spread across Semester 1 and Semester 2 (2 hours teaching per week) [Ref.: DCU M&S, Item 2.2.1; Teaching Council]

### 2. Derogations from Marks & Standards

#### 3. Progression

Normally students must successfully have completed a minimum of 25 credits in Year 1 in order to progress to Year 2. Students will not be permitted to 'carry' modules under any circumstances [Ref.: DCU M&S, Item 7.2.1].

# 4. Compensation
