SECTION A: MINUTES AND RELATED ISSUES

1. Adoption of the agenda

2. Minutes of the meeting of 31 March 2016

The minutes of the meeting of 31 March 2016 were approved and signed by the Chair.

3. Matters arising from the minutes

3.1 The Associate Deans for Teaching and Learning provided a brief report on category 3 modules (no resit continuous assessment). It was <u>noted</u> that the majority of modules identified as category 3 were delivered on Faculty of Science and Health programmes and it was reported that it was unlikely that the categorisation of those modules would change. It was <u>noted</u> that DCU Business School and the Faculty of Humanities and Social Science do not categorise modules as category 3 (Item 6).

- 3.2 It was clarified that the *DCU Feedback to Support Student Learning Policy* document circulated at the meeting of USC of 31 March 2016 was a sub-section of a document also containing information on Assessment. It was confirmed that this document, (containing both assessment and feedback information) is the final approved version, and subject to some minor formatting, would be published on the web shortly (Item 3.2).
- 3.3 It was <u>noted</u> that the Recognition of Prior Learning (RPL) policy was under consideration (Item 3.3).
- 3.4 It was <u>noted</u> that the drafting of proposals with respect to issues related to the external examiners' process was ongoing (Item 3.4).
- 3.5 It was <u>noted</u> that the update with respect to Akari was awaiting further system development (Item 3.6).
- 3.6 It was <u>noted</u> that the students previously registered on the MSc in Plasma and Vacuum Technologies whose registration, if they return to the programme, will exceed the maximum registration period have been contacted by the Programme Chair (Item 3.1).
- 3.7 It was <u>noted</u> that the exploration of the possibility of awarding posthumous undergraduate Certificates/Diplomas would be discussed with the Vice-President for Academic Affairs/Registrar and explored in the new academic year 2016-2017 (Item 8.2).
- 3.8 It was <u>noted</u> that the legacy re-admission application for a candidate on the MSc in Guidance Counselling had been re-submitted and <u>approved</u> by Chair's Action on 25 May 2016 (Item 5.1.1, 31 March 2016).

3.9 It was <u>noted</u> that the External Experts for the Period Programme Review of the BA in Media Production Management in the Ballyfermot College of Further Education had been <u>approved</u> electronically by USC on 13 April 2016. The External Examiner for the same programme was <u>noted</u>.

The derogation from Marks and Standards (3.1.1, Module size) requesting the inclusion of 2.5 credit modules for Gaeilge and English modules on the BA in Humanities programme for year 3 students for the academic year 2016-2017 was considered. This request is to facilitate the final year of students who commenced on the St Patrick's College BA in Humanities programme. It was <u>noted</u> that the year 3 structure has been revised and all subjects will include modules with a minimum of 5 credits from the academic year 2017-2018. The derogation was <u>approved</u>.

5.2 Faculty of Science & Health

5.2.1 Derogation request: Higher Diploma in Psychiatric/Mental Health Nursing

The request for a derogation from Marks and Standards (6.2.2) for the Higher Diploma in Psychiatric/Mental Health Nursing was <u>approved</u> subject to a change of wording from 'Compensation is not permitted between theory and practice components of practice modules' to 'Students must pass both theory and practice components of practice modules'.

5.2.2 Faculty Policy on the approval of proposed registration onto Faculty Stand-alone modules

The addendum to the Faculty of Science and Health policy on the approval of standalone modules was <u>noted</u>. There was some discussion on the operationalisation of the process and it was requested that the Faculty policy also includes communication in writing to the student that the additional module being taken might lead to potential examination timetable clashes.

The changes proposed to the *Academic Regulations for Postgraduate Degrees by Research and Thesis* were approved, subject to the following additions/amendments:

• The statement as follows '.. a decision to make a research award may be annulled if plagiarism...' was changed to a decision to make a research award may be rescinded if plagiarism...'

• Inclusion of a statement indicating that the transfer exam needs to be a separate process to the PGR2 process.

10. Any other business

10.1 Consideration of proposal for a derogation from Marks and Standards for the Master of Education (Special Educational Needs, (CICE)

It was <u>noted</u> that, subject to a decision by Education Committee at its meeting of 1 June 2016, it was anticipated that a derogation with respect to the Master of Education (Special Educational Needs) may need to be considered by University Standards Committee over the summer months. The Secretary indicated she would be in touch in this regard.

10.2 Approval of minutes of meeting of 26 May 2016

It was <u>noted</u> that the USC minutes of 26 May 2016 would be circulated to be approved electronically in advance of Academic Council which will take place on 20 June 2016.
