#### SECTION A: MINUTES AND RELATED ISSUES

### 1. Adoption of the agenda

The agenda was adopted subject to placing items 5.2.2 and 5.2.3 under the heading DCU Institute of Education and renumbering accordingly, and the addition of four items under AOB.

### 2. Minutes of the meeting of 26 May 2016

The minutes of the meeting of 26 May 2016 were noted and signed by the Chair.

### 3. Matters arising from the minutes

3.1 It was <u>noted</u> that the Deputy Registrar/Dean for Teaching and Learning and the Secretary of USC had met with the Associate Deans for Teaching and Learning in July 2016 to discuss some ongoing USC items. It was <u>noted</u> that since the introduction of the Guru system to support the activities of External Examiners the issues around communication and provision of reports had become less of an issue.

It was <u>noted</u> that discussions will continue with respect to the appointment of external examiners and the oversight of programmes e.g. programme rather than module external examiners (Item 3.4).

- 3.2 It was <u>noted</u> that the Recognition of Prior Learning (RPL) policy was discussed at the meeting referred to under item 3.1. It was agreed that the RPL policy would be amended to reflect a broad set of principles. It was <u>noted</u> that it was agreed by those at the meeting to adapt the DCUBS template 'special case admission form' for dealing with taught postgraduate admissions in other Faculties. It was <u>noted</u> too that RPL with respect to undergraduate students should be discussed further with Registry (Item 3.3).
- 3.3 It was <u>noted</u> that the Akari project was close to conclusion and was at the stage of data clean-up (Item 3.5).
- 3.4 It was <u>noted</u> that all programme regulations with the exception of some programmes from the DCU Institute of Education were approved by USC.
- 3.5 It was <u>noted</u> that the exploration of the possibility of awarding posthumous undergraduate Certificates/Diplomas was ongoing (Item 3.7).
- 3.6 It was <u>noted</u> that discussions between the Dean of Graduate Studies and Registry with respect to the procedure for rescinding an award in the case of plagiarism for research students had yet to take place (Item 9).
- 3.7 It was <u>noted</u> that the derogation for the MEd (Special Educational Needs), CICE had been circulated electronically and approved by University Standards Committee on 5 July 2016 (Item 10.1).
- 3.8 It was <u>noted</u> that a change of duties for an external Examiner in the Department of English had been approved by Chair's Action, 6 July 2016.

# 7. Annual Programme Review (APR) Form

It was <u>noted</u> that the APR Form has been reviewed by the Associate Deans for Teaching and Learning and amendments made to streamline it. USC was asked to provide feedback on the content of the form to Dr Caroline McMullan over the coming week. Once finalised it would be published on the web. It was <u>noted</u> too that a communication will issue at Faculty level from the Associate Deans for Teaching and Learning/Education to Programme Chairs to inform them of the change to the APR form.

It was anticipated that work would also commence over the coming months to facilitate the population of the statistical element of the APR form via Guru.

#### 8. AOB

8.1 Publication date Programme Regulations 2016-2017 and archiving from 2015-2016

The Secretary informed the Committee that the approved Programme Regulations would be published by Monday 12 September 2016, noting that from 2015-2016 Programme Regulations would be archived and remain available on the DCU website.

#### 8.2 Examination Timetable Principles

The document, *Examination Timetabling Principles to be adopted in the Academic Year 2015-2016* was tabled for consideration. It was <u>noted</u> that the principles adopted in 2015-2016 would now be applied to all students registered with DCU from 2016-2017.

During the discussion on the document the following were noted:

- Feedback from students from the Faculty of Engineering and Computing indicated their exams were condensed into four days of the two-week examination period. It was requested that this issue be brought to the attention of Registry when the examination request call takes place
- Among the restrictions placed on the examination timetable is the requirement that all BEd programme examinations have to be scheduled in the second week of the two-week schedule, which has a significant impact on the overall timetable
- Students' expectations should be managed with respect to the examination timetable
- It was requested that where two examinations are scheduled on the one day for a cohort of students, they are not examinations for two different languages. This request had been accommodated last year.
- The examination principles are published as an appendix to the Examination Regulations on the Registry website.

Subject to feedback recorded above being taken into consideration, USC <u>approved</u> the application of the Examination Timetabling Principles as tabled.

#### 8.3 Minor amendment to Legacy Re-admission form

It was requested, and <u>agreed</u> that the legacy re-admission application form would be updated to include the applicant's most recent contact details to enable Registry to contact the candidate about their registration.
