#### SECTION A: MINUTES AND RELATED ISSUES

## 1. Adoption of agenda

The agenda was adopted subject to the inclusion of three submissions under Item 12.

### 2. Minutes of the meeting of 5 May 2011

The minutes were confirmed and signed by the Chair.

# **3.** Matters arising from the minutes

3.1 <u>Noted</u> that confirmation that Academic Council had approved the revised *Academic Regulations for Postgraduate Degrees by Research and Thesis* had been made available on 30 May 2011. <u>Noted</u> that these regulations would be discussed by Faculty Research Committees in 2011/12 with a view to monitoring their fitness for purpose. <u>Noted</u> too that they include a stipulation that having theses proofread/edited on a commercial basis is not permitted. (Items 3.2 and 3.7)

- **3.2** <u>Noted</u> that the issue of making 2.5-credit modules available as part of Graduate Training Elements would be discussed at a future meeting of the GSB. (Item 3.3)
- **3.3** <u>Noted</u> that the Graduate Training Elements for the Faculty of Science and Health had been approved electronically by the GSB on 16 May 2011. (Item 3.4)
- **3.4** <u>Noted</u> that a Memorandum of Understanding between the University, St Patrick's College and Dundalk Institute of Technology in respect of a joint doctoral programme was being drawn up, and that this was consonant with the statement by the President at the 27 June 2011 meeting of Academic Council that it would be desirable to seek opportunities for strategic collaboration with DKIT. <u>Noted</u> that DKIT is also a partner in the BioAT structured PhD programme. (Item 3.5)
- **3.5** <u>Noted</u> that a School is in the process of identifying an alternative external examiner for a student. (Item 3.6)
- **3.6** <u>Noted</u> that, when the PGR2 (annual progress report) is being revised, provision will be made for the listing on it of the members of the supervisory panel. (Item 3.7)
- **3.7** A proposal for the attribution of credits for attendance at a Summer School by students from the School of Communications was <u>approved</u>. <u>Noted</u> that the issue should be integrated, on a retrospective basis, into the academic structures in the Faculty of Humanities and Social Sciences, and that this would be done. <u>Noted</u> that results would be dealt with by the Graduate Research Assessment Board (see Item 11 below). (Item 3.8)
- **3.8** <u>Noted</u> that the Daniel O'Hare Scholarships would be announced on 1 July 2011, that they would be directed towards research likely to lead to the creation of knowledge in the areas of innovation, sustainability and social cohesion, and that the application form would be more detailed and rigorous than had been the case in 2009/10. (Item 3.9)
- **3.9** <u>Noted</u> that discussions about a possible transfer student are ongoing in a School. (Item 3.11)
- **3.10** <u>Noted</u> that the proposals on Higher Doctorates had been approved by Academic Council at its meeting of 27 June 2011. (Item 3.16)
- **3.10** <u>Noted</u> that discussions were in progress about the supports available for students whose native language is not English and that a future GSB meeting would consider the issues pertaining to the small number of students admitted without having met

the University's English-language requirements. (See also Item 10 below.) (Items 3.17 and 9)

- **3.12** <u>Noted</u> that discussions are in progress with both NAIRTL and DCU Human Resources Office about the provision of supervisory training programmes. (Item 3.18)
- **3.13** <u>Noted</u> that information about the nature and extent of external examining experience had been obtained in respect of three nominated external examiners, and the nominations had been approved. (Items 5.2, 5.3 and 5.23)
- **3.14** <u>Noted</u> that a nominated external examiner had been approved on the basis that it had been ascertained that his nomination was not in contravention of regulations. However, to avoid a situation in which there might be conflict of interest, an alternative internal examiner had been approved by means of Chair's action on 7 June 2011. (Item 5.18)
- **3.15** <u>Noted</u> that satisfactory details about the publications of a nominated external examiner had been obtained, and the nomination had been approved. (Item 5.21)
- **3.16** <u>Noted</u> that the format of the last section on the pro-forma *curriculum vitae* within the PGR4 (notification of intention to submit thesis for examination) form had been changed. (Item 5)

# 8. **Proposed Graduate Training Elements**

None.

# 9. Proposed research Master's in Bioinnovation

- 9.1 In the discussion about this proposal, the following were <u>noted</u>:
  - while the numbers on the proposed programme will be small, it is strongly supported by industry and may serve as a model for analogous programmes in the future
  - it is important that DCU be seen to be a leader in this field
  - the modules are available not only to those taking the programme but to a maximum of twenty-eight research students across the partner institutions
  - the award of MSc will be made by DCU
  - the award will appear as 'MSc' on the parchment; the word 'Bioinnovation' will not appear; the area of specialism will be apparent from the results in the transcript
  - while the entry requirements appear quite broad, it is expected that, in practice, only very highly-qualified candidates will apply
  - on the matter of whether or not a follow-on PhD programme would be required, it is considered, at present, that there is no need for this; the situation will be revisited if necessary; previous requests from medical doctors to be admitted to PhD programmes have been the subject of discussion within the University.
- **9.2** The proposal was <u>approved</u> subject to verification that no contravention of Marks and Standards would be involved (e.g. in terms of credit rating or duration of period of study). <u>Agreed</u> that the Chair would notify the Deputy President/Registrar, Professor Anne Scott, of the outcome of the discussion.
- **9.3** <u>Agreed</u> that a request would be made to the Education Committee to have the issue of award titles generally discussed, and parameters outlined and approved.

## **10.** Revised proposal on English-language requirements

In the discussion about this proposal, concern was expressed that lowering requirements without putting adequate support systems into place for students with relatively weak English might not be in the students' best interests. It was <u>agreed</u> that the proposal would be submitted for discussion in Faculties with a view to being on the agenda of the GSB again, at its meeting of 3 November 2011. It was further <u>agreed</u> that Dr Morrissey, who had submitted the proposal, would discuss the issues with the International Office and would also ascertain what levels of English-language support are available in other universities. (See also Item 3.11 above.)

# 11. Request in respect of Graduate Research Assessment Boards and sign-off of provisional results

- **11.1** <u>Noted</u> that the request had been approved. <u>Noted</u> that resit opportunities would not normally be available to research students who failed taught modules and that the expectation was that they would repeat a failed module, or take an appropriate alternative module, in the next academic session.
- **11.2** <u>Noted</u> that issues relating to the entering of grades for taught modules would be discussed by relevant staff members outside the context of the GSB.

## 12. Any other business

# **12.1** Recording and publication of transfer/confirmation oral examinations in the School of Computing

The Chair introduced this item by <u>noting</u> that he had been asked by Professor Josef van Genabith to ascertain the view of the GSB on the practice currently used in the School of Computing whereby students seeking transfer to or confirmation on the PhD register have their presentations recorded for the purposes of placing them on the school's website for public availability.

Professor van Genabith raised a number of concerns about this practice and the Chair then sought the view of Professor Michael Scott, Head of the School of Computing, on the issue. The Chair began the discussion by presenting to the GSB a document which outlined the viewpoints of both Professor van Genabith and Professor Scott. Significant concern was expressed about the practice, on the following grounds:

- ethical issues arise in respect of obtaining student consent, particularly given the indication that a good reason would be expected in situations where a student chose not to have recorded material go on line, the absence of clarity around the issue of the timing of the request for consent, and the power imbalances that necessarily exist in a situation where a student is being examined
- recording and making the examination available on line would be likely to create stress for the student, particularly if consent had to be obtained prior to the examination; it is not usual to make other elements of examination processes publicly available
- legal issues pertaining to the rights of funding bodies would need to take precedence over any desire to record the results of research and make them available on line; issues of intellectual property rights and confidentiality would be likely to arise
- the research being presented would not be in final form because the student would not have completed the research programme
- the role of the supervisor in respect of the proposal is not clear.

It was <u>agreed</u> that the concerns of the GSB should be made known to the School of Computing, to the University's Executive and to the University's Research Ethics Committee.

It was <u>noted</u> that, if the School wished to record student presentations with a view to supporting the students and helping them to improve their performance at oral examinations, this would be a different matter, as it would not involve public dissemination of the research and would not be likely to lead to the concerns mentioned above.

# 12.2 Chairing of Complaints Review Committee meeting

<u>Agreed</u> that it would be appropriate for the Chair to act as chair of an upcoming Complaints Review Committee meeting, subject to the agreement of the Deputy President/Registrar, Professor Anne Scott.

# 12.3 Final meeting for inaugural GSB Chair

The Chair <u>noted</u> that this would be his last GSB meeting, he having chaired the GSB since its inception in September 2007. He expressed sincere appreciation to all his colleagues on the GSB, past and present, for having contributed to making his experience as Chair such a positive one. Professor Costello, on behalf of the members, thanked the Chair for his excellent work over the past four years.
