**SECTION A: MINUTES AND RELATED ISSUES****1. Adoption of the agenda**

The agenda was adopted.

**2. Minutes of the meeting of 27 February 2020**

The Masters programme has not been validated (item 8.1 and 8.2).

### **5. Updates to Academic Regulations for Postgraduate Degrees by Research and Thesis 2020-2021**

The proposed amendments to the regulations for 2020-21 were considered by GRSB. In addition to minor edits and corrections for the purpose of clarity, the following changes were agreed:

- 1.1.1: Clarification that the 30 credits are not additional for enterprise-focused research.
- 1.1.3 and 1.2: Tentative addition of new programme titles, subject to accreditation and approval by Academic Council.
- 3.3: Update to clarify entry requirements for Professional Doctorate applicants with a taught Masters.
- 7.7.1: Removal of references to the 'DCU Retired Staff Research Agreement' which has not been approved.
- 9.3.2: Addition of the following statement regarding restriction of access: 'The time period of restriction will commence based on the time of publication by the library. A retrospective application for restrictions may not be requested once the thesis has been published'.

- 10.1: Expansion of the eligibility criteria for the appointment of internal examiners, to include 'The Internal Examiner may not be a member of the candidate's supervisory panel, but should be experienced in supervising research students (such as having supervised 3 candidates from early stage through the confirmation/transfer stage and/or has completed all elements of professional development for examiners (course and where applicable exam shadowing with reflection)'
- 11.3.5: Addition of the following statement 'Audio/video recording of the viva voce examination will not be permitted...'

## 6. Updates to PGR3 form

The updated PGR3 form, which includes additional guidance to examiners and supervisors, was considered. It was agreed that the wording 'if required' should be removed from Section C of the form. Subject to this amendment, GRSB approved the updated form.

## 7. Review of English language derogation for research students

### 7.1 Faculty of Engineering & Computing

The report was noted. The Chair requested that the report be updated to include a statement from the Faculty on the request to extend the derogation.

## 8. Covid 19—Continuity Arrangements

The Chair updated the GRBS on a number of Covid related matters:

### Viva Voce

The Chair informed the Board that a number of examinations have taken place using video conferencing. Procedures for conducting a *viva voce* using videoconferencing are being followed. The Chair has requested that he be notified of all upcoming examinations so that the GSO can provide guidance and support to Chairpersons as needed. A report prepared by the Chair on *viva voce* conducted by zoom to date will be circulated to the ADRs shortly.

### Ongoing Supports for Research Students

There was a discussion on the supports being provided to research students during this time. The Chair informed the Board that the GSO are working on moving training and other supports online and that student have been directed to DoctoralNet in the interim. The Chair highlighted the issue of oversubscription to online supports as evidenced in a recent

writing support workshop facilitated by the GSO. There were some suggestions from the ADRs as to how pastoral support can be provided during this time. The Chair welcome suggestions and input from the ADRs. Pastoral, training and other supports will be a focus of the GSO in the coming weeks.

#### Scholarships

The Chair advised the Board that the IUA have sent letters to the main funders highlighting that extensions to registration periods will only be feasible if they coincide with a commitment by funders to extend scholarship periods. It is anticipated that a response from funders will be forthcoming shortly.

#### Submission of softbound theses

The Chair is liaising with Registry and the Registrar on alternatives to the submission of physical softbound copies of theses to Registry. Changes to the process will be communicated to students once finalised.

#### Card-fees

The issue of extended registrations was raised and the implication this will have on fees. It was suggested that any decision to extend the card fee deadline should be made as soon as possible to provide certainty to students. It was agreed by the Chair that he would consider this matter.

### **8.1 Alternative test to replace the International English Language Testing System (IELTS) for DCU Admissions—interim arrangement**

The recently approved 'Alternative test to replace the International English Language Testing System (IELTS) for DCU admissions – interim arrangement' was circulated. It was noted that students admitted through this mechanism will be assessed and provided with supplementary English language supports as appropriate.
