# 2. Minutes of the meeting of 4 April 2013

#### 3. Matters arising from the minutes

- Noted that the policy on assessment had been approved by the Education Committee at its meeting of 29 May 2013, subject to minor amendments, and that the revised version would be submitted for the consideration of Academic Council at its meeting of 24 June 2013. (Item 3.1)
- 3.2 <u>Noted</u> that an issue relating to NARIC would not now be progressed and required no further discussion. (Item 3.3)
- 3.3 Noted that, with respect to a number of ongoing items, updated information would be provided to the USC as and when possible and appropriate. (Item 3.6)
- 3.4 Noted that a pilot project was under way in SALIS aimed at improving student attendance at lectures and seminars by means of including class participation requirements in module learning outcomes. The outcome of the pilot is awaited and will be of particular relevance to other disciplines in the Faculty in which, as is the case for Languages, attendance and participation are of critical importance. (Item 3.13)
- 3.5 Noted that, in Spring 2014, a report would be submitted to the USC about the effectiveness of the inclusion, in the programme regulations 2013/14 for the Faculty of Humanities and Social Sciences, of information on resit categories. (Item 3.13)
- 3.6 Noted that the revised USC terms of reference would be submitted for the consideration of Academic Council at its meeting of 5 June 2013. (Item 3.14)
- 3.7 Noted that the revised title 'Graduate Research Students Board' would form part of the revised terms of reference of the Graduate Studies Board, to be submitted for the consideration of Academic Council at its meeting of 5 June 2013. (Item 3.15)

3.8 <u>Noted</u>, in the case of a nominated external examiner, that the nomination was within regulations in terms of prior appointments and had therefore been deemed approved. (Item 5.1.4)

- Noted that the proposed changes to English-language requirements, on a pilot basis, for non-native speakers who apply for admission to programmes in the Faculty of Engineering and Computing had, subject to their being applied to all Schools in the Faculty, been approved by Academic Council at its meeting of 10 April 2013 and would be implemented. Noted that the EC had been notified of the proposal. (Item 6.1.1)
- 3.10 Noted that the first part of the work of the working group on external examiners had been completed, i.e. the rewriting of parts of *Regulations and Guidelines: External Examiners for Taught Programmes/Modules*, and that the group would progress the other aspects of its work (including consideration of the extent to which a representative sample of work from all modules should be sent to external examiners) as soon as possible. Noted that the revised *Regulations and Guidelines* had been approved by Academic Council at its meeting of 10 April 2013 and publicised to stakeholders, and that they had come into effect. (Item 9.1)
- 3.11 With respect to the policy on academic integrity and plagiarism, it was <u>noted</u> that Professor Eithne Guilfoyle, Vice-President Academic Affairs (Registrar), had advised that it would be essential for it to be fully intelligible to all readers, and that to that end, if resources permitted, contact would be made with NALA, the National Adult Literacy Agency, with a view to using their advice service on plain English in respect of the policy. <u>Noted</u> that the policy would be submitted for the consideration of Academic Council at its meeting of 5 June 2013. It was <u>agreed</u> that, in the event that legal advice proved necessary in the future with respect to any aspect of the policy, it would be sought. (Item 10.1)
- 3.12 Noted that Academic Council had, at its meeting of 10 April 2013, approved the existence of the revised form and procedure with respect to legacy admission requests. Noted that all stakeholders had been informed about the new form and procedure. (See also Item 6 below.) (Item 8)

## 6.4 Dublin City University Business School

# 6.4.1 Request for readmission of legacy candidate: MSc in Investment, Treasury and Banking

<u>Approved</u> subject to a stipulation that the proposed maximum completion time be indicated as one year.

Noted that only the new form and procedure are to be used with respect to legacy admission requests. (See also Item 3.12 above.) This means, *inter alia*, that direct representation from candidates will not be countenanced by the USC. Noted that the new form and policy would be reviewed for fitness for purpose at the end of the academic year 2013/14. Noted that the question as to whether the candidate was willing to comply with readmission conditions might more usefully ask whether the candidate was aware of them, and agreed that this issue would form part of the review. Noted that it would be helpful to have a procedure to assist Programme Chairs in answering the question as to whether previous readmission requests had been made by the candidate on a legacy basis. Noted that, in time, the availability of electronic transcripts was likely to facilitate consideration of legacy readmission requests.

#### SECTION C: OTHER ISSUES (NOT FACULTY SPECIFIC)

#### 7. Marks and Standards issues

## 7.1 Proposed revisions to Marks and Standards

Approved subject to the following:

- the indication of the version as '2013.1'
- the deletion of the second proposed sentence at 'Supplemental Award' in Section 1.1.
- the inclusion in relevant tables of a reference to 'Professional Master's', as a major award at Level 9 and with modules at Levels 8 and 9, and with a minimum of 90 credits
- the inclusion above the new sentence in current Section 2.4 of an additional new sentence: 'For any major award, a minimum of 60 ECTS credits must be at the level of the award.'
- the renumbering of these two sentences as Section 2.5 and the consequent renumbering of subsequent subsections of Section 2
- the addition of a definition of 'previous contribution' to the glossary. Noted that the revised Marks and Standards would be submitted for the consideration of Academic Council at its meeting of 24 June 2013.

## 7.2 Proposal in respect of Section 2.2.4 of Marks and Standards

It was agreed, following discussion, that no change was required to Section 2.2.4.

## 7.3 Proposal in respect of Section 2.4 of Marks and Standards

It was <u>agreed</u>, following discussion, that no change was required to Section 2.4 but that the issues would be kept under review.

#### 7.4 Request for derogation: Professional Diploma in Taxation

Decision deferred pending receipt of details of the stipulation from the Irish Tax Institute which would render the derogation necessary and/or clarification as to whether or not Chartered Accountants Ireland might require the derogation (if it recognises the PDT as an entry qualification). <u>Agreed</u> that consideration could, if necessary, be given to making the derogation available on a per-module basis.

### 7.5 Issue in respect of the MSc in Plasma and Vacuum Technology

Noted that this programme would not run, as such, in 2013/14 but that modules from it would be offered on a stand-alone basis, and that the derogations from Marks and Standards which apply to the programme as a whole would also apply to the stand-alone modules.

#### 7.6 Issue in respect of the MEng in Healthcare Technologies

<u>Noted</u> that compromise Marks and Standards had been approved in the context of the accreditation process for this programme to reflect the fact that it is a 3U Partnership programme.

#### 7.7 Programme regulations 2013/14

Noted that the majority of these regulations were available for consultation on the V drive and that the remainder would be made available as soon as possible. Agreed that Friday 5 July 2013 would be the deadline for approving the regulations. Noted that, where regulations included the word 'draft' (e.g. as a watermark), this did not mean they were liable to change by Faculties but rather indicated that they were subject to approval by the USC. Noted that a small number of regulations for 2012/13 (for the BSc in Nursing, MSc in Psychotherapy and MSc in Integrative Counselling and Psychotherapy) had been replaced on line with fully updated versions.

## 8. Revised Academic Regulations for Postgraduate Degrees by Research and Thesis

Approved. Noted that the revised regulations on eligibility to supervise students reflected current realities in terms of contractual issues for academic staff. Noted that the thrust of the revised regulations on dispute resolution was to utilise fully and appropriately the existing University mechanisms rather than creating parallel mechanisms. With respect to situations in which an experienced practitioner wishes to supervise a PhD student but does not him/herself hold a PhD or an associate professorship or professorship, it was noted that the individual could participate in the supervisory panel even though ineligible to be principal supervisor. Noted that the revised Academic Regulations would be submitted for the consideration of Academic Council at its meeting of 24 June 2013.

## 9. Issues in respect of remote examinations

<u>Noted</u> that feedback was being collated on the basis of the examinations held to date in 2012/13 in remote locations and that this would inform a proposal on the issue to be submitted by the Chair and Ms McMorrow to the meeting of 12 September 2013.

# 10. Proposed external experts for Periodic Programme Review, Autumn 2013: programmes in the School of Communications

<u>Approved.</u> <u>Agreed</u> that consideration of such experts, for all Faculties, would henceforth be a standing item on the last meeting of the USC of each academic year. <u>Agreed</u> that the Chair would speak to Faculties to ensure that all of them were making preparations for PPR in Autumn 2013 and had identified, or were in the process of identifying, external experts for this purpose whose details would be submitted for approval to the USC.
