The Chair welcomed members to the first meeting of Graduate Research Studies Board (GRSB) of the new academic year noting that this was the first meeting post incorporation, with a reduced Board membership. The Chair welcomed Mr Allen Stevenson, representing postgraduate research students, to his first meeting.

SECTION A: MINUTES AND RELATED ISSUES

1. Adoption of agenda

The agenda was adopted subject to the addition of three items under AOB.

2. Minutes of the meeting of 5 September 2016

The minutes of the meeting of 5 September 2016, were <u>approved</u> and signed by the Chair.

3. Matters arising from the minutes of 5 September 2016

- 3.1 It was <u>noted</u> that the individual Joint Supervision Agreements with the Military University of Technology in Warsaw and the University of Southampton were awaiting final ratification from each of the participating institutions (Item 3.1).
- 3.2 It was <u>noted</u> that discussions with Registry with respect to the administrative arrangements to be put in place to run the Graduate Training Elements (GTE) module GS611 over a two-year period were ongoing (Item 4.2a).
- 3.3 It was <u>noted</u> that Registry were awaiting a response from the School of Human Performance with respect to a follow-up query from GRSB relating to the nomination of an external examiner from a closer geographical location (Item 10.29).
- 3.4 It was <u>noted</u> that the Chair had met with the Heads of School of Electronic Engineering to discuss issues raised during consideration of two requests for extension to the maximum registration (Items 11.8 and 11.9).
- 3.5 It was <u>noted</u> that the Chair had met with Heads of School to ask them to promote engagement with Research Integrity Training at School level (Item 6).
- 3.6 It was <u>noted</u> that the proposed minor changes to the Academic Regulations for Postgraduate Degrees by Research and Thesis discussed briefly at the 5 September 2016 meeting of GRSB were on the agenda of this meeting for further discussion (Item 8).
- 3.7 It was <u>noted</u> that the transfer to the PhD register (PGR3) of a candidate from the School of Education Studies had been completed following the requested submission of a more detailed report on the candidate's written submission (Item 9.13).
- 3.8 It was <u>noted</u> that the transfer to the PhD register (PGR3) of a candidate from the School of Law and Government had been completed. Confirmation had been received that an oral exam had taken place and the exam involved both the internal examiner and principal supervisor (Item 9.17).
- 3.9 It was <u>noted</u> that the transfer to the PhD register (PGR3) of a candidate from the School of Nursing and Human Sciences had been completed. Confirmation had been received that the oral examination had taken place, and the process had been conducted in line with regulations (Item 9.19).

- 3.10 It was <u>noted</u> that as requested by GRSB, the School of Biotechnology had submitted an alternative nominee for the external examiner (PGR4) and the nomination was on the agenda (Item 10.2) of this meeting (Item 10.4).
- 3.11 It was <u>noted</u> that following the meeting of 5 September 2016, an external examiner, previously approved for a candidate in the School of Chemical Sciences was identified as not being eligible to be an external examiner and an alternative nominee was sought. The revised nomination (Item 10.5) is on the agenda of this meeting (Item 10.12).
- 3.12 It was <u>noted</u> that the notice of intention to submit form (PGR4) for a candidate in the School of Computing was deemed approved following confirmation of the qualification of the nominated external examiner (Item 10.13).
- 3.13 It was <u>noted</u> that the notice of intention to submit form (PGR4) for a candidate in the School of Computing was deemed approved following confirmation of the previous experience at DCU of the nominated external examiner (Item 10.16).
- 3.14 It was <u>noted</u> that the notice of intention to submit form (PGR4) for a candidate in the School of Human Development has been resubmitted (Item 10.11) for the consideration of this meeting of GRSB (Item 10.18).
- 3.15 It was <u>noted</u> that the decision on the notice of intention to submit form (PGR4) for a candidate in the School of STEM, Education, Innovation and Global Studies, was deferred at the last meeting of GRSB and has been re-submitted (Item 10.17) for the consideration of this meeting (Item 10.21).
- 3.16 It was <u>noted</u> that the notice of intention to submit form (PGR4) for a candidate in the School of Nursing and Human Sciences was deferred at the last meeting of GRSB and has been resubmitted (Item 10.14) for the consideration of this meeting (Item 10.34).

- 3.18 It was <u>noted</u> that for the application to extend the maximum registration (PGR14) for a candidate in the School of Communications, it had been confirmed that permission had been granted for the student to study abroad (Item 11.4).

- 3.19 It was <u>noted</u> that the candidate from the School of Nursing and Human Sciences whose extension of the maximum registration (PGR14) had been approved for a second time by GRSB, had been advised that the same rationale for extension would not be considered for a third time (Item 11.13).
- 3.20 It was <u>noted</u> that the minor amendments to the PGR14 and PGR6 forms suggested at the GRSB meeting of 5 September 2016 had been completed (Item 12).
- 3.21 It was <u>noted</u> that a re-submitted (expired) notice of intention to submit form (PGR4) for a candidate in the School of Chemical Sciences had been approved by Chair's action on 6 September 2016 (Item 2016/A6/10.37).
- 3.22 It was <u>noted</u> that an application to extend the maximum registration (PGR14) for a candidate in the School of Law and Government was approved by Chair's Action, 12 September 2016 (2016/A6/11.14).
- 3.23 It was <u>noted</u> that an application to extend the maximum registration (PGR14) for a candidate in the School of Law and Government was approved by Chair's Action, 23 September 2016 (2016/A6/11.15).

SECTION B: Policy and strategy issues

4. Graduate Researcher Development

There were no items for consideration relating to Graduate Research Development.

The Chair <u>noted</u> the recent formal launch of the DCU ENRICH Framework on 19 September 2016 and provided a copy of the recently published information on the framework to the Board. She outlined that the framework has been developed to enable graduate researchers identify the skills and competencies for development to assist them in preparing for work in a variety of settings beyond academia. It is hoped that Schools would consider including the framework when designing doctoral pathways. The Graduate Studies Office staff offered to attend School meetings over the coming months to raise awareness of the framework and to seek to embed the framework into doctoral pathways.

The Chair <u>noted</u> her thanks to Ms Rachel Keegan for her work in the development of the ENRICH framework.

5. Incorporation Update

It was <u>noted</u> that the Incorporation process has been completed with the signing of the legal agreements on 30 September 2016. With respect to the final stages of Incorporation relating to graduate students, the following were noted:

- The majority of transfer students have now been transferred and registered in their new Schools
- Registry is awaiting the transfer of files for a small number of students.

6. GRSB Standing Committee to consider Appeals

The revised membership of the GRSB Standing Committee to consider Appeals was <u>approved</u>. It was <u>agreed</u> that membership of the Committee would be approved on an annual basis, to take account of the changes in personnel which can occur each year.

It was <u>noted</u> that the Secretary of GRSB would be in touch to arrange a meeting over the next number of weeks for any appeals submitted by the upcoming deadline of 21 October 2016.

7 Report on GRSB activities 2015-2016

The report on GRSB activities 2015-2016 was <u>noted</u>. The Chair extended thanks to members of GRSB for the work achieved in 2015-2016 and in particular the introduction of new PhD formats, the clarification of the existing regulations and the work completed in the introduction of supports (online tools and resources) for research students.

8. Minor amendments to Academic Regulations for postgraduate degrees by Research and Thesis

The Chair outlined that at the 5 September 2016 meeting of GRSB the absence of a gender mix of examiners at the stage of transfer/confirmation on the PhD register and at the approval of the examination board stage was raised as a concern. The Academic Regulations for Postgraduate Degrees by Research and Thesis contains the following stipulation 'in line with the University's policy and stated commitment to best practice in equality issues, Heads of School must ensure, in so far as possible, a balanced gender representation in the appointment of examiners to the examining team for research awards'. The Chair had reviewed the regulations

to explore whether there could be a more overt reference to gender balance/mix at every stage of the research examination process, however she came to the conclusion that to stipulate the requirement for example at the confirmation/transfer stage would put a heavy constraint on schools in terms of finding staff members with the relevant academic discipline and of the required gender in every case.

Following a brief discussion it was <u>agreed</u> that the wording in the Academic Regulations for Postgraduate Degrees by Research and Thesis would be amended and the phrase 'gender balance' would be replaced with 'gender mix'.

12.1 Changes to academic title conventions

In the context of considering examiner nominations, the Chair drew colleagues' attention to the fact that two Irish universities had changed their post titles, and equivalence with DCU titles could not be assumed.

12.2 QQI and IUQB Research Guidelines

The Chair informed the Board that a second draft of the QQI draft guidelines on quality assurance of research degrees, replacing the draft originally circulated in July 2016, would issue shortly for consultation. She indicated that this draft would be a more concise, higher level document.

A revision of the IUQB 2009 document *Good Practice in the Organisation of PhD Programmes in Irish Universities* was also expected to begin this year.

12.3 Meeting with Science Foundation Ireland

It was <u>noted</u> that, in the context of the IUA Deans group, the Chair had met recently with Professor Mark Ferguson, Director General of Science Foundation Ireland. He had indicated that there is likely to be an SFI funded programme at doctoral level.

It was <u>noted</u> by the Director of RIS that Professor Ferguson had raised the issue of the responsibilities of supervisors and the implications for them of a breach of research integrity policy by a student under their supervision. In the discussion which followed, it was suggested that it would be beneficial that new supervisors complete the DCU training on Research Integrity. As this is a decision that would require discussion and support at Faculty level, the Chair asked that Associate Deans for Research raise the issue at Faculty Research Committees.
