# 2. Minutes of the meeting of 2 March 2017

The minutes of the meeting of 2 March 2017, were approved and signed by the Chair.

# 3. Matters arising from the minutes of 2 March 2017

3.1 It was <u>noted</u> that the Research Abroad Guidelines document would be the subject of discussion of a sub-group of GRSB which the Chair intended to convene over the coming weeks (Item 6).

- 3.2 It was <u>noted</u> that discussions are ongoing with respect to a Joint Supervision Agreement with the University of Southampton (Item 3.2).
- 3.3 It was <u>noted</u> that feedback on the Residing Abroad Guidelines from the Faculties of Science and Health and Engineering and Computing will be provided at the sub-group of GRSB (see item 3.1 above) (Item 6).
- 3.4 It was <u>noted</u> that feedback had been provided by the Faculty of Engineering and Computing with respect to new supervisors being required to take the Research Integrity module and clarification with respect to existing staff was yet to be provided (Item 6).

- 3.9 It was <u>noted</u> that the relevant section in the Academic Regulations for Postgraduate Degrees by Research and Thesis is being amended to address any issues which may arise in the sign-off on corrections of a PhD thesis following completion of the examination (Item 12.4).

#### 4. Graduate Researcher Development

Members were reminded that any GTE modules currently under development should be submitted for the consideration of the June 2017 meeting of GRSB.

The Chair tabled a document containing information on upcoming training events for research students, supervisors and chairpersons of examining panels. He requested that

Associate Deans encourage colleagues and students to attend and indicated he would circulate the information electronically to faculties.

# 5. Recognition of Prior Learning Policy (RPL) for Research Students

It was <u>noted</u> that following consideration of an RPL application at the 2 March 2017 meeting of GRSB a discrepancy between the RPL policy itself and the related section in the Academic Regulations for Postgraduate Degrees by Research and Thesis was highlighted. The following amendments were suggested to the policy

- Deletion of PhD track from the list of research programmes to which RPL applies
- Change to the following sentence 'The admission of candidates not holding a prior degree or equivalent'....

It was noted that the RPL Policy would be considered by a sub-group of GRSB and the outcome of discussions would be referred to GRSB.

It was <u>agreed</u> that the sub-group would be made up of the following members of GRSB: the Chair and Secretary, the Associate Deans for Research, a member of the Graduate Studies Office, Registry representatives and the student representative.

#### 6. Doctorate in Education, Programme Regulations

The programme regulations for the Doctorate in Education were <u>noted</u>.

Following a brief discussion it was <u>noted</u> that:

- The exit award title MPhil (Education) should be added to the list of degree titles listed in Marks and Standards
- The requirement for approval in another forum would be clarified.

### 7. Draft Guidance Document for Resolution of Student/ supervisor Issues

It was <u>noted</u> that discussion on the Draft Guidance Document for Resolution of Student/supervisor Issues would be considered by the sub-group of GRSB and the outcome of discussions would be referred to GRSB.

#### 8. Guidance on the Role of the Independent Panel Member

It was <u>noted</u> that discussion on the Guidance on the Role of the Independent Panel Member would be considered by a sub-group of GRSB and the outcome of discussions would be referred to GRSB.

# 9. Academic Regulations for Postgraduate Degrees by Research and Thesis 2017-2018

The changes proposed to date to the Academic Regulations for Postgraduate Degrees by Research and Thesis 2017-2018 were <u>agreed</u> subject to the following:

- Renumbering subsections in Section 1
- Add in 'or equivalent' under paragraph 3.6
- Add 'where applicable' to paragraph 4.2
- Amendment to footnote (paragraph 7.1) reflecting the supervisory panel exemption applying to students transferring from the former linked college, St. Patrick's College Drumcondra and registered before 2 March 2016
- Amendment to paragraph 7.1.4 to provide clarity that a 'new' principal supervisor is an academic member of staff who has not yet brought two PhD students to conclusion. It was requested and <u>agreed</u> that this definition would also apply when considering those who are required to attend Research Integrity training.
- To ascertain if it is appropriate to use the word 'mix' in the context of gender representation.

It was <u>agreed</u> to include a justification of gender representation of examining panels on the PGR4 form.

It was <u>noted</u> that additional changes to the Academic Regulations for Postgraduate Degrees by Research and Thesis 2017-2018 would be expected, arising from the following:

- Consideration by a sub-group of GRSB of the documents Draft Guidance Document for Resolution of Student/ supervisor Issues and Guidance on the Role of Independent Panel Member and Research Abroad Principles
- Consideration of feedback provided by Registry.

The Chair indicated that the final version of the Academic Regulations for Postgraduate Degrees by Research and Thesis would be considered by the sub-group of GRSB and referred to the 18 May 2017 meeting of GRSB for final approval. It was also <u>noted</u> that the Academic Regulations would be submitted for the approval of University Standards Committee on 25 May 2017.
