The Chair welcomed Ms Rachel Keegan to the meeting in her new capacity as Secretary. The Chair thanked the outgoing Secretary, Ms Margaret Irwin-Bannon, for her work and support to the GRSB and the Dean of Graduate Studies.

#### **SECTION A: MINUTES AND RELATED ISSUES**

## 1. Adoption of the agenda

The agenda was adopted, subject to

The Chair noted that there were two items to be raised under AOB.

## 2. Minutes of the meeting of 28 February 2019

The minutes of the meeting of 28 February 2019 were <u>approved</u> and signed by the Chair.

## 3. Matters arising from the minutes of 28 February 2019

3.1 The Chair provided an update on item 8.1 of the meeting of the GRSB on 17 January 2019. After the decision of the GRSB, the Chair was informed that the applicant did not meet DCU English language requirements. This information was not made available to the GRSB at the time of considering the special-case admission. The Chair <u>noted</u> that the applicant has since met the English language requirements and the decision of the GRSB on 17 January 2019 stands (Item 8.1).

- 3.2 It was <u>noted</u> that work to address the gender mix of examining panels is ongoing (Item 3.3).
- 3.3 It was <u>noted</u> that work on guidelines on recital/performance, and related capacity building is ongoing (Item 3.4).
- 3.4 It was <u>noted</u> that work on a timeline for consideration of PGR4 forms for Professional Decorates is ongoing (Item 3.6).
- 3.5 It was <u>noted</u> that follow-up with respect to a PGR3 form for a student in the School of Law and Government, where insertion of the oral report in the correct section of the form and the provision of additional details on both the written and oral examination was requested, was completed (Item 3.7), (original ref. 5.33, 3 Sep 2018).
- 3.6 It was <u>noted</u> that follow-up with respect to a PGR3 form for a student in the School of Computing, where provision of more detail in section B(i) and B(ii) of the form was requested, is still ongoing (Item 3.9), (Original ref. 9.7, 25 October 2018).
- 3.7 It was <u>noted</u> that follow-up with respect to a PGR4 form for a student in the School of Chemical Sciences, where the nomination of a new internal examiner, new independent chair and provision of full citation of publications was requested, was completed (Item 9.5).
- 3.8 It was <u>noted</u> that guidelines in respect to PhD by Publication format is on the agenda (item 6) of this meeting (Item 3.5).
- 3.9 It was <u>noted</u> that guidance in respect of remote supervision of research students is on the agenda (Item 5) of this meeting (Item 3.10/7).
- 3.10 It was <u>noted</u> that a PGR4 form for a student in the School of Theology, Philosophy and Music, which was deferred, due to the nomination of an external examiner from the RIAM with which DCU has a linked agreement, is on the agenda (Item 9.45) of this meeting (Item 9.12).

3.11 It was <u>noted</u> that a PGR14 form for a student in the School of Chemical Sciences in which the approval was on hold, was completed (Item 3.1), (Original ref. 12.1, 25 October 2018).

- 3.12 It was <u>noted</u> that further exploration with Registry enrolments team, to determine when the PGR13 should be submitted in the context of the admission process, was completed (Item 7).
- 3.13 It was <u>noted</u> that follow-up with respect to a PGR3 form for a student in the School of History and Geography, where to the provision of an alternative countersignature was requested, was completed (Item 8.2).
- 3.14 It was <u>noted</u> that follow-up with respect to a PGR3 form for a student in the School of History and Geography, where clarification on the registration of the student was requested, was completed (Item 8.3).
- 3.15 It was <u>noted</u> that a PGR14 form for a student in the School of Mechanical and Manufacturing Engineering was approved on 22 March 2019 by chair's action.

#### **SECTION B: Policy and strategy issues**

### 4. Graduate Researcher Development

4.1 GTE Module LG609 Research Design for the Social Sciences

The module was <u>approved</u> subject to the following changes to the submitted descriptor:

- The NFQ level should be set at 9 in keeping with other GTE modules.
- The learning outcomes should be updated to reflect level 9 learning.
- The taxonomy can be left blank until guidance is provided on how to complete this table.
- It was noted that the module appears to be primarily quantitative. If so it is suggested that this be called out in the module title.
- 4.2 GTE Module LC603 Advanced Readings in Applied Linguistics

The module was <u>approved</u> subject to the following changes to the submitted descriptor:

- The NFQ level should be set at 9 in keeping with other GTE modules.
- Learning outcome 2 makes direct reference to the assessment output rather than to the learning. This should be amended.
- A more detailed breakdown of the assessment is required. Specifically, the effort involved/size of the abstract, and how participation will be assessed (for example, requiring students to submit reflections on learning).
- Under the module workload section, it is suggested that 'fieldwork' may be more accurately described as 'independent study'.

### 5. Guidance in respect of remote supervision of research students

The new *Guidance in Respect of Remote Supervision of Research Students* was discussed by the Board, with particular emphasis on the GRSB notification and approval timelines as current specified in the *Academic Regulations for Postgraduate Degrees by Research and Thesis* (ref. sections 4.5 and 7.1).

Feedback from the Faculties regarding the timeframe ranges was discussed including a suggestion that authority for approval of all remote supervision agreements might be devolved to faculty level.

It was <u>agreed</u> by the Board that the current regulations should remain for the 2019-20 academic year, to allow for the revised agreement template and associated guidance document to be trialed.

It was <u>agreed</u> that the Board would revisit this item in 2019-20 with a view to piloting devolved authority to faculty level for 2020-21.

It was <u>agreed</u> that the revised remote supervision agreement template would be included with the PGR13 paperwork on the Registry website, effective immediately.

# 6. Guidelines for candidates, supervisors and examiners on the 'PhD by Publication' format

The new *Guidelines for candidates, supervisors and examiners on the 'PhD by Publication' Format* was discussed by the Board. It was agreed that this is a useful document. It was <u>noted</u> that the 'signed statement' referred to on page 3 should be changed to 'declaration of authorship'. It was <u>noted</u> that 'The word count for the thesis...' on page 4 should be changed to 'The maximum word count for the thesis...'

The proposed template *Declaration of co-Authorship* was considered by the Board. It was <u>noted</u> that the document should be renamed *Declaration of Authorship* and references to 'co-authorship' should be changed to 'authorship' throughout. There was a discussion on the most appropriate location of such declarations within the softbound thesis and whether they are required in the hardbound thesis. It was <u>noted</u> that the Academic Regulations also need updating to reflect this new declaration.

Feedback from faculties was sought on the proposed guidelines and declaration. It was <u>agreed</u> that an updated guidelines document and declaration be brought to the May meeting of the GRSB.

# 7. Amendments to Academic Regulations for Postgraduate Degrees by Research and Thesis 2019-2020
