The Dean provided the GRSB with a verbal update on the draft PhD by Publication guidelines. The guidelines were circulated to faculties following the May meeting of the GRSB. There were no further suggested amendments to the document at this time, however, ongoing feedback is welcomed and the guidelines may be revised in light of their effectiveness in practice. It was <u>noted</u> that these guidelines are complete and will be published on the GSO website.

There was a brief discussion around the regulations in regards to presenting a PhD by Publication. It was <u>noted</u> in particular that the requirement for papers to be published/accepted for publication are particular preventative in some disciplines. It was <u>agreed</u> that there is merit in exploring PhDs by Publication in the coming academic year.

6 Minimum registration submission timelines
