SECTION A: MINUTES AND RELATED ISSUES

The Chair opened the meeting and welcomed colleagues to the last meeting of GRSB of the academic year 2018-2019.

1. Adoption of the agenda

It was <u>noted</u> that there were two corrections to the agenda as follows: Item 8.10, change PhD to MPhil Item 8.36, change reference from 8.35 to 8.36

2. Minutes of the meeting of 20 June 2019

The minutes of the meeting of 20 June 2019 were approved and signed by the Chair.
