## SECTION A: MINUTES AND RELATED ISSUES

# **1.** Adoption of the agenda

## 2. Minutes of the meeting of 23 May 2019

The minutes already approved electronically were signed by the Chair.

#### 3. Matters arising from the minutes of 23 May 2019

**3.1** It was <u>noted</u> that the development of an approval procedure relating to the non-progression of individual students who fail semester one teaching practice on the PMEP programme is ongoing (Item 3.2).

- **3.2** It was <u>noted</u> that the external examiner nomination (item 4.1.8, 23 May 2019 meeting) was conditionally approved by Chair's action subject to the nomination of additional examiners for the BEd and PMEP programmes. It was <u>noted</u> that two additional examiners were submitted for approval and are on the agenda (items 4.1.2 and 4.1.5) of this meeting and the issue of workload would be discussed in this context (4.1.8).
- **3.3** It was <u>noted</u> that a first draft of the External Examiner handbook has been drafted and following consultation with the Associate Deans for Teaching and Learning/ Education would be on the agenda of the November 2019 meeting of USC.
- **3.4** It was <u>noted</u> that operationalisation of the new module type was completed (Item 3.1).
- **3.5** It was <u>noted</u> that work in ensuring that the linking to programme regulations on the Loop programme page can be done as efficiently as possible on an annual basis is ongoing (Item 3.3).
- **3.6** It was <u>noted</u> that USC would review the practice of attendance monitoring, as reflected in the programme regulations, in November 2019 (Item 8).
- **3.7** It was <u>noted</u> that work to ensure that the title of the person nominated to approve the nomination of external examiners (in place of the Head of School) appears appropriately on the EE1 form was completed (Item 3.4).
- **3.8** It was <u>noted</u> that following a request from USC, it was arranged that the average number of modules that a programme external examiner will examine in any given year will appear on the EE1 form outputted from Guru (Item 3.7).
- **3.9** It was <u>noted</u> that the updated Marks and Standards 2019.1 document was approved by Academic Council on 17 June 2019 (Item 6).
- **3.10** It was <u>noted</u> that minor items of clarification were completed on the Recognition of Prior Learning policy and the document was approved by Academic Council at its meeting of 17 June 2019 (Item 7).
- **3.11** It was <u>noted</u> that the nomination of an external examiner for the School of Nursing, Psychotherapy and Community Health, a decision on which was deferred at the 23 May 2019 meeting, is on the agenda (4.1.7) of this meeting (Item 4.1.3).

The proposed external examiner was approved however, University Standards Committee expressed serious concerns about the workload attaching to the external examiner appointments for the BEd and PME (Primary) programmes. They recommended, in order to ensure the workload is manageable for the four external examiner concerned, that the focus of the examiners would be on the final years of the programmes and that the other years of the programmes could be reviewed on a rotational basis. It was <u>noted</u> that this recommendation is in line with the DCU Regulations and Guidelines for External Examiners for Taught Programmes.

5.2.1 Derogation from Marks and Standards for BSc in Actuarial Mathematics

**Proposed**: A minimum of 40% must be achieved in both the examination and continuous assessment elements for an overall pass in MS117, Probability I.

<u>Approved</u>, it was <u>noted</u> that the module descriptor should be amended to reflect that separate learning outcomes would be examined in the continuous assessment and examination elements, as the module requires a student to pass both elements.
