5. Other issues: Faculty

5.1 **Faculty of Engineering and Computing**

5.1.1 Legacy readmission: MSc in Computing

5.1.2 Derogation from Marks and Standards: BEng/MEng in Mechatronic Engineering

In the discussion on this derogation application, the Chair indicated that the derogation was not related to the requirements of a professional body, rather the issue of fifteen additional credits (255 rather than 240) was the outcome of the design of the BEng/MEng programme and as a result it did not meet the conditions of a derogation. It was recommended that the project would be included in the credits for the award and advised that not all credits had to be included for the classification of the award.

It was noted that there were other programmes within the Faculty that used the 255 credit structure and it was agreed that the Associate Dean for Teaching and Learning in the Faculty of Engineering and Computing would have a further discussion with the Chair in this regard.

It was noted that this application was an unusual case as this student should technically be registered *ab initio* as the date of his last registration was in excess of eight years. However, University Standards Committee agreed, in this particular circumstance only, that the student could register for third year directly, and that they should be exempted from the 3rd year modules already completed.

C: Other issues (not Faculty-specific)

6. Marks and Standards 2021.1

The following changes to Marks and Standards were highlighted.

- Addition of 'Professional Diploma in' to award titles list (the award was part of Table 1, but not named in the award title list (Section 1.2.1)
- Change to classification of level 7, 8 and level 9, Certificate and Diploma awards (Section 8.3 and Section 8.5) (approved by USC, 25 February 2021) and addition of footnote that this change will not apply retrospectively
- Minor amendments, formatting and numbering of the document

Marks and Standards version 2021.1 was approved for referral for approval to Academic Council.

7. Programme Regulations 2021-2022

7.1 DCU Business School

It was noted that the issue of the 2.5 credit module for the first year undergraduate programmes had been resolved through structure changes and that there were no further substantial changes to the regulations.

The regulations circulated in advance of University Standards Committee were approved.

7.2 DCU Institute of Education

It was noted that changes to the programme regulations were minor.

The regulations circulated in advance of University Standards Committee were approved.

7.3 Faculty of Engineering and Computing

It was noted that the changes to the programme regulations included new programmes, adjustment to marks calculation, covid-related amendments and reflected some structure changes to the programme for students from Wuhan.

The regulations circulated in advance of University Standards Committee were approved.

7.4 Faculty of Humanities and Social Sciences

It was noted that the main changes were related to adjustments to structures to accommodate students taking the year abroad.

The regulations circulated in advance of University Standards Committee were approved.

7.5 Faculty of Science and Health

It was noted that the main changes were minor; the result of new programmes or entry points e.g. Common entry into Chemistry and Biology and arrangements around repeat students.

The regulations circulated in advance of University Standards Committee were approved.

7.6 Open Education

It was noted that the main change to the regulations were to retain category 1 status for modules that were originally category 2 but were changed to category 1 in the context of Covid-related arrangements last year.

The regulations circulated in advance of University Standards Committee were approved.

8. Academic Regulations for Postgraduate Degrees by Research and Thesis 2021-2022

The Academic Regulations for Postgraduate Degrees by Research and Thesis 2021-2022 were approved.

9. Framework for consideration of students with outstanding assessment material for Category 2 modules in exceptional circumstances

The Chair provided a briefing to USC on the proposed framework. A sub-group of USC had met on 13 April 2021 and had agreed that a proposal should be developed to enable a wider application for consideration of students with outstanding assessment material for category 2 modules in Faculties other than Science and Health. However, the Chair found in developing a proposal, it was difficult to clearly define the circumstances in which a framework would work more generally. He noted particularly that for Faculties, other than Science and Health the issue was with fourth year projects and defining what 'not completed' meant. He suggested that a better solution would be to change the module category from category 2 and make it clear that there would not be supervision beyond the normal timeframe for students who were submitting at a later point. He sought the views of USC on this proposal.

The following were noted from the discussion:

- In Open Education, the relevant modules had been amended to category 1 modules, however the Science and Health framework had been very useful in advising students on the specific criteria they could postpone.
- If the project type modules were changed to category one modules, then it could lead to students taking advantage of extra time and lead to inequity, even if the criteria were very specifically defined.
- The Science and Health proposal was in very limited circumstances and is time-defined.
 It would not be logistically feasible to create another type of examination period over the summer for undefined circumstances.
- It was suggested that final year projects might be best dealt with by classifying them as category 1 modules and dealing with the exceptions in the usual way (extenuating circumstances, deferral etc.).

It was suggested, that rather than develop and adopt a framework for other Faculties now, it would be useful to review the operation of the framework in the Faculty of Science and

Health in a year's time and to then have a broader discussion when the outcomes are known. This proposal was agreed.

10. Any other business

The Chair noted that this was the last meeting before the summer and thanked the Committee for its work during the year, and wished members a good summer.
